As we head into the budget season, I wanted to make sure that our community members are aware of opportunities for input into our budget decision-making process. I was recently appointed to the five-member Budget and Finance Committee at the Board of Supervisors, which reviews and holds public hearings on the Mayor's proposed budget for each upcoming fiscal year. With three years of experience working directly with the City's budget, I plan to put to use my expertise and knowledge of the budget process to ensure our residents have a voice in prioritizing the resources needed for our neighborhoods.

With a projected \$338 million deficit for the City's 2008-2009 budget, I encourage you to contact me and share any concerns you have regarding the budget. I will also be holding office hours in the district, where I will provide updates on the budget process and listen to your input. Stay tuned to our newsletter for more information on these meetings.

I have also recently been appointed as Chair of the City Operations and Neighborhood Services Committee, which reviews legislation related to public works, infrastructure, parks and recreation, utilities, public protection, delinquency prevention, public health, emergency services, seniors, the disabled, children and their families. In my new role as Chair of the committee, I look forward to serving as a strong voice for residents when considering legislation that would affect our neighborhood and families.

## OCEAN BEACH RENOVATION IN THE WORKS



Many will agree that we can improve conditions along Ocean Beach. In an attempt to transform the five-mile stretch of beach and its surroundings, Mayor Gavin Newsom announced on March 18 the formation of an Ocean Beach Vision Council. The Council brings together members of the sustainable planning and environmental design community with government agencies and community leaders with the goal of developing a set of planning alternatives with a 30-50 year horizon for the beach.

Supervisor Chu will be working jointly with other members of the Council, which includes Assemblywoman Fiona Ma, Supervisor Jake McGoldrick, Golden Gate

National Recreation Area (GGNRA) Superintendent Brian O'Neill, Jared Blumenfeld of the Department of the Environment, Scott Preston of the environment-based planning and design firm EDAW, Clark Manus of Heller Manus Architects, Jean Rogers of ARUP, LaraTruppelli of Beach Chalet Brewery and Restaurant, and Gabriel Metcalf of the San Francisco Planning and Urban Research Association. Supervisor Chu's objective is to make sure Sunset residents are not overlooked and have a direct voice in the shared vision.

During the next year, the Ocean Beach Vision Council will work jointly with the community to develop a draft master plan that outlines how we can support Ocean Beach and the surrounding area, similar to how the Crissy Field plan transformed a former Army motor pool into the San Francisco waterfront's premier outdoor recreational facility.

#### HONORING ONE OF OUR OWN: OFFICER MARY BURNS

Each year, the Board of Supervisors and the Commission on the Status of Women

honor San Francisco "Women Making History" during Women's History Month. At the Board's March 4<sup>th</sup> meeting, Supervisor Chu recognized Taraval Police Station Officer Mary Burns. A San Francisco native, Officer Burns has dedicated herself to helping others since she joined the

San Francisco Police Department in 1984. In 1990, Officer Burns was one of only four women assigned to the Tenderloin Task Force which, in its first year, made over 200 arrests, more than any other station.

Officer Burns later became a trainer at the Police Academy and her

achievements earned her the Police Department's Instructor of the Year Award in 2003. Since returning to the Taraval Station, Officer Burns has dedicated herself to assisting neighbors on key issues. Congratulations to Officer Burns!

#### **MUNI COMMUNITY MEETING – COMING SOON**

The Municipal Transportation Agency (MTA) has been undergoing an 18-month project – the Transit Effectiveness Project (TEP) – to review, evaluate and make recommendations on the existing MUNI transit system to improve service and make public transportation more reliable. This is the first comprehensive review of our City's transit system in over 25 years. Supervisor Chu requested that MTA listen to community feedback before drafting any route proposals, and held a community meeting in January to discuss the transit lines. MTA has now developed route recommendations for MUNI lines, and will be seeking community feedback on these proposed changes. Supervisor Chu will be hosting another meeting with MTA on **April 26 (Sat) from 10:30am – 12:30pm** at Dianne Feinstein Elementary School's multi-

purpose room to review MTA's plans and hear residents' input before these proposed route changes are acted upon. It is important that the community voice is heard before any changes happen! Please visit <u>www.sftep.com</u> for details on the proposals and to learn more about the TEP.

## PEDESTRIAN SAFETY MEASURES INSTALLED

Pedestrian safety continues to a priority, and we are happy to announce the recent installation of three new radar speed limit signs around school areas. The three new radar speed limit signs have been installed at Ortega Street (40<sup>th</sup> Ave – Eastbound); Ortega & Pacheco Street (41<sup>st</sup> Ave, south of Ortega – Northbound); and Rivera Street (38<sup>th</sup> Ave – Westbound). These signs are placed near AP Giannini Middle School, Sunset Elementary School and St. Ignatius College Preparatory.

It is important that we continue to find ways to enhance safety in neighborhoods, including where schools are located. The high volume of pedestrians and traffic through these areas warrant increased attention, and our office will continue to work with city departments to implement safety measures for our children and families. The radar speed limit signs display the speed of oncoming vehicles and start flashing when a vehicle has surpassed the speed limit. The signs also collect data on speed for all vehicles that drive by.

#### Judi Gorski



In the early 1970's at age 19, Judi A. Gorski dropped out of the University of Miami, hitchhiked from Florida to San Francisco, made it her permanent home, and worked in law offices while majoring in painting at San Francisco State University. After graduating with a B.A. in Art, her dream to live and work creatively in a waterfront location came to pass.

In 1991, married to attorney Stephen J. Gorski, with their son, then 7-year old Justin, Judi opened JAG's Art Studio at the Beach, 2366 48<sup>th</sup> Avenue, San Francisco, with her first open studio. Today, she daily welcomes the public to a self-guided tour of her three story home/studio/gallery. Amid the various ocean views, visitors see over 100 paintings, mobiles, prints and other

handmade treasures for sale. Judi produces commissioned paintings and volunteers for community service projects; she helped restore the graffiti damaged mural on 40<sup>th</sup> Avenue at Ortega Street in the Sunset District in 2003 and is currently a member of ArtSpan's Auction and Open Studio Committees.

Her reputation as "San Francisco's Surfer Artist," grew from the public's recognition of her photorealistic acrylic paintings and limited edition giclee prints of surfers which are continuously featured on the walls of Wise

Surfboards, 800 Great Highway, and in Java Beach Café, 1396 La Playa @ Judah, and other local venues. Figures in her paintings are often neighbors and friends who share a connection to the beach environment.

Judi proudly says, "People from all over the world come to San Francisco's Ocean Beach to appreciate its beauty and add to it their own energy, colors and memories. I'm one of those people, making paintings from the heart about the place where I love to be living."
