### MESSAGE FROM THE SUPERVISOR

Safety in our Neighborhood

Pedestrian and traffic safety continues to be one of the top concerns we hear about in our office. To address this issue. our office has been working with the community, the Department of Parking and Traffic (DPT), and the Department of Public Works (DPW) to come up with ways to mitigate accidents in our neighborhood. Most recently, we completed a project along Yorba Street on both 36th Ave and 37th Ave after a number of residents approached our office with concerns about the safety within these large and oftentimes confusing intersections. New medians were installed at these two intersections to help guide drivers, prevent potential

collisions due to the lack of visibility for vehicles coming from certain directions, and reduce vehicle speed. Our office worked with DPW, neighbors, and volunteers from Lincoln High School on May 8<sup>th</sup> to complete the project by planting within these two medians. In addition, the MTA will be exploring an eastbound stop sign at Yorba and 37<sup>th</sup> Ave.

The Yorba Street islands are one element of a traffic calming plan for the Crestlake area that also includes speed bumps and red zones at low visibility corners, all aimed to reduce speeds in the area. ### MEDICAL CANNABIS DISPENSARY AT 2139 TARAVAL

The Medical Cannabis Dispensary proposed for 2139 Taraval & 32<sup>nd</sup> Avenue was approved by the Planning Commission last month. The Planning Department recommended approval for the project because the location met the criteria of being more than 1,000 feet from a recreation center and middle or elementary school. Although almost 4,000 residents voiced their concerns on this issue, and well over 100 residents attended the Planning Commission meeting to voice their opposition to the project, the Planning Commissioners approved the project and did not find extraordinary or exceptional reasons to deny the permit.

### SAFETY IMPROVEMENTS FOR N-JUDAH TERMINUS AT LA PLAYA



Neighbors have raised concerns regarding safety at the N-Judah turnaround at Judah Street & La Playa. Specifically, residents have expressed concerns about visibility for pedestrians, drivers and bicyclists who need to navigate this intersection while a train is parked in the middle of the intersection. To address this, we

held neighborhood meetings on April 23<sup>rd</sup> and June 3<sup>rd</sup> with officials from the Department of Parking and Traffic (DPT) to explore options for parking the N-Judah train.

After careful consideration of Federal disabled access requirements and the community's concerns, DPT presented findings on proposed solutions from community members, as well as their recommended solution for the intersection. We are currently gathering neighborhood feedback on the recommended solution. ### **EMERGENCY RESPONSE TRAINING IN THE SUNSET**

Help your neighborhood be prepared for the next earthquake or any emergency by becoming a NERT (Neighborhood Emergency Response Team) volunteer. NERT trainings happen regularly but this month you can train right here in the Sunset.

This Sunset District session will be held on **Tuesday evenings** at the Sunset Ministry, 3010 Noriega. If you can't make this session, visit www.NERT.org for classes at other locations and times.

If you cannot make all sessions you may make up classes at other locations in the city. At graduation you get a cool yellow helmet, orange vest and the satisfaction of becoming more prepared in the event of an emergency.



The goal of this program is to help the residents of San Francisco be self sufficient in a major disaster situation by developing multi-functional teams, cross-trained in basic emergency skills.

Through this program, individuals will learn hands-on disaster skills that will help them as members of an emergency response team and/or as a leader directing untrained volunteers during an emergency, allowing them to act independently or as an adjunct to City emergency services.

There is **no cost** for the neighborhood training, and the class sessions are approximately 3 hours.

A NERT volunteer is anyone who wants to be active and involved in the community. NERT teams are best formed in neighborhoods through a partnership with existing community

groups such as a Neighborhood Watch program, Rotary Club, business group, faith based group or homeowners association. Together with their neighbors, team members and coworkers, they build a NERT network within their own community, teaming with the San Francisco Fire Department. All residents can benefit from NERT training. (Participations under 18 require the signature of a parent or guardian.)

NERT connects volunteers with a network of fellow volunteers all working together for a common cause. NERT members are not shelter workers; they are trained citizen first responders who can help save lives.

The NERT Training Program is a 20-hour comprehensive program consisting of 6 class sessions. Delivery of these 6 sessions is offered in a variety of scheduling options. The training instructors are professional firefighters. There is no cost for our neighborhood training classes. There is a fee for private training. For more information, call: (415) 970-2022.

#### SUNSET RECREATION CENTER RENOVATION

Later this year the long awaited renovation to the Sunset Recreation Center (28<sup>th</sup> Ave & Lawton) will begin. This \$13.7M project is funded by the 2008 Clean and Safe Neighborhood Parks bond.

The renovation means that for about a year, the busiest recreation center in the district will be under construction and unavailable for use. The Recreation & Park Department is



working on relocating many activities and will be holding a community meeting in the next few months to provide information and alternatives. Our office will have details about that meeting as soon as it is confirmed.

Throughout the planning process, the Rec & Park Department held several public meetings, in which the project managers presented plans for the new park, listened to the community,

considered ideas and suggestions, implemented the feasible ones and presented new plans for public review. After all the public meetings and input, the plan was then presented to the Rec & Park Commission and was approved unanimously.

One issue that has recently come up is the perimeter of the park itself. The Lawton Street entrance will have a curvilinear grassy band leading to the two playground areas. Along Moraga, between 28th and 29th Avenues, the existing trees will remain, complimented with "planting beds" of sustainable, low maintenance plants. In between the planting beds will be a porous and permeable surface that is accessible to pedestrians and dog walkers. This landscaping was selected to reduce ongoing maintenance costs at the park while preserving access.

A number of questions have come up with regards to dog access to the recreational area. With the exception of the athletic field and children's play area, dogs will be welcome on leash throughout the park provided their litter is picked up.

### **FIRST 5 SF PARENT ACTION GRANTS**

The San Francisco Children and Families Commission (First 5 SF) has a small grants program centered around the goal of parent empowerment. It has four general categories:

- Community Building
- Parent Education
- Leadership Development
- Family Activities

There are two types of grant applications. The **Starter Grant** is intended for parent groups supported by agencies (community based organizations, preschools, elementary school kindergarten classrooms, church groups, etc.) for parents with children ages 0 to 5. The Starter Grant is a pre-cursor to the **First Year Grants**, which are intended to build agency staff capacity on parent engagement by facilitating a group of parents to design and implement their own projects and is intended for parent groups with or without agency support. Parents are expected to take on more responsibilities on their own to design and implement the projects.

# TENNESSEE GRILL

If you're looking for a hearty "stick to your ribs" breakfast, an after-school milkshake, a good burger and fries, or to catch up with the latest neighborhood news -- then the Tennessee Grill is the place to go. The Tennessee Grill has been an institution for nearly 60 years, having first opened in 1952 by an individual originally from Tennessee. In 1970, current proprietor Lou Duenas took over after two years of working at the restaurant. Prior to his career at Tennessee Grill, Lou worked at Bank of America, quit his job there, joined the restaurant business, and he's been there ever since.

"It's a homely kind of restaurant, and you meet your friends here," Lou said of the Tennessee Grill.
