Message from the Supervisor



I am excited to announce that Saturday, September 10th at 11:00am marks the grand re-opening of West Sunset Playground and Ortega Branch Library. As a major community hub for Sunset District residents, West Sunset has served generations of families, and we invite you to participate in the celebration!

## West Sunset Playground

Located next to A.P. Giannini Middle School and the Ortega Branch Library, West Sunset Playground is one of the most heavily used playgrounds on the west side of the city. Our office began working with community members in 2007 to have the outdated playground rebuilt.

Built in 1978, the playground saw its share of improvements that needed to be made and the aging structures were no longer serving the children in a safe way. The new playground will have an increased play area, and will also be updated to comply with Federal Americans with Disabilities Act (ADA) standards.

The design of the playground also takes into consideration public safety issues, and the new playground will be more visible from Ortega Street. The playaround's surrounding courtyard area will also feature more seating areas for to accommodate family activities. In addition to the playground, the courtyard leading to Ortega Branch Library is also undergoing a renovation to address safety issues from the uneven pavement.

This rebuild project was the result of a huge collaborative effort between community members, including the Friends of West Sunset Playground (FOWSP), and the city's Recreation & Park and Public Works Departments. A group of parents who frequented West Sunset Playground with their children formed the FOWSP in an effort to get the playground rebuilt. They worked for years to fundraise, organize playground clean-up events, and generate community awareness about the rebuild and maintenance of the playground. I would like to thank everyone who took time out of their busy days to ensure that many more generations of families can continue to enjoy West Sunset Playground.

#### Ortega Branch Library

The new Ortega Branch Library was designed and managed by the Department of Public Works with input from the community beginning in 2003 after voters passed a bond measure in November 2000 to upgrade San Francisco's branch library system. The new and expanded library, going from 5,000 square feet to 9,000 square feet, will be seismically safe, closer to

Ortega Street for added visibility and safety of patrons, will have approximately 40 percent more seats, more than 20 public computers including laptops for lending at the library, designated teen and kids spaces, and an expanded library collection space. Through the public input process, neighbors expressed interest in a program room open to community members, and the new Ortega Branch includes a new program room that can be used by the community even after library hours.

The Friends of the San Francisco Public Library has been working in partnership with neighborhood residents and communities to raise funds, awareness and support for the Ortega Branch Library improvements. # **UPCOMING NEIGHBORHOOD IMPROVEMENT EVENT**

On Saturday, **September 24th**, the Department of Public Works will be holding the Community Clean Team/Gigantic 3 Recycling Event in the Sunset District. # ADA WORKSHOP HELD IN THE SUNSET

Providing equal access for everyone has always been the intent behind the Americans with Disabilities Act (ADA). However, many small businesses throughout San Francisco and the state of California have been hit with "drive-by lawsuits" targeting businesses for noncompliance.

Our office has been working with the Office of Small Business, Mayor's Office on Disability and the Bar Association of San Francisco to educate merchants about requirements under the Americans with Disabilities Act (ADA). Together, we have worked on centralizing important information about the ADA, and have been working actively to share information on resources available to businesses through merchant walks, merchant association meetings, mailings to all restaurants in the city, and most recently, an ADA workshop held at the Taraval Police Station on August 3.

The workshop featured speakers from the Bar Association of San Francisco, Office of Small Business, Mayor's Office on Disability, and Opportunity Fund. # CPUC SMART METER "OPT OUT" WORKSHOP

You have probably heard about the new Smart Meters™ that PG&E has been installing. These new meters replace the old analog meters, and are said to allow customers to view hourly electric and daily gas energy usage data, valuable information that can be used to make smarter energy choices. PG&E uses wireless radios attached to an electric meter to send customer usage information securely and wirelessly with its SmartMeter™ devices to PG&E for data collection. Some customers have expressed concerns about potential health effects related to radio frequency (RF) emissions from the meters and have asked PG&E to not install them in their homes. Last Spring, PG&E proposed an "Opt Out" program for people who do not want the Smart Meters™ installed in their homes, and the California Public Utilities Commission is still reviewing that proposal. In the meantime, the Administrative Law Judge in this case has requested a public workshop to consider the various options for customers to opt-out of the Smart Meter™ program. This workshop is scheduled for Wed. Sept. 14 and is open to the public.
