am proud to say that several programs and projects have been allocated funding through the budget process that will directly benefit the residents of the Sunset District. These include:

- Seed funding to build a restroom facility located at the intersection of 45th Avenue and Lincoln Way;
- Funding to conduct a traffic analysis around Sloat Boulevard and Great Highway as part of SPUR's (San Francisco Planning and Urban Research Association) Ocean Beach Master Plan, which would potentially close Great Highway south of Sloat Boulevard to address erosion and safety issues, and create a natural trail area;
- Funding for enhanced cleanliness along vital business corridors on Irving, Noriega and Taraval; and
- Rebuilding a jogging path on Sunset Boulevard between Pacheco and Lincoln Way.

Through efforts like the Sunset District Blueprint, we are excited to build a framework to guide our office in providing the resources that District 4 residents need. Our office will continue to advocate for funding to support the programs



and projects most important to District 4 residents, and I ask that through the Sunset District Blueprint project, you continue to provide your input on budget priorities for the Sunset District.

Together, we can ensure that District 4 receives the fiscal support it needs to continue its vitality.

## New Sunset Outstation for Aging and Disability Resource Center (ADRC)

n July 10, Supervisor Tang, along with representatives from the ADRC of Episcopal Community Services of San Francisco, the San Francisco Public Library, Sunset Branch Library and Sunset District community members, celebrated the opening of a new Sunset outstation at the Sunset Branch Library located on 1305 18<sup>th</sup> Avenue at

Irving Street.

ADRC provides seniors and adults with disabilities free and upto-date information, referral, and assistance to help maximize self-sufficiency, safety, health, and independence. At ADRC outstations, individuals can receive help in the following areas: housing and shelter; medical and dental care; employment and training opportunities; case management services; transportation; immigration information; legal services; nutrition, translation services; paperwork and application assistance; and many other community resources.

The current hours at the new Sunset Library location are: every Wednesday from 10:30 am to 12:30 pm and every Friday from 1:30 pm to 2:30 pm. Services are offered at the Children's Room in the basement of the library.

# Sunset District Blueprint Update

n July's newsletter, we discussed the first workshop in our comprehensive Sunset District Blueprint, a proactive plan for short and long term improvements in the Sunset District. The first of five interactive workshops was held on June 13<sup>th</sup> and focused on Transportation and Pedestrian Safety.

The second workshop on Land Use was held on Thursday June 18<sup>th</sup>, and over 40 community members showed up to provide their input on land use issues in the Sunset District. Participants focused on discussing three facets of Land Use: permitting and zoning; policy; and specific geographic issues and opportunities through an interactive mapping activity. Residents worked with representatives of city agencies including the Planning Department, the Public Utilities



Commission and the Recreation and Park Department to discuss their ideas and submit their suggestions for the Blueprint.

The third workshop on Economic Development will take place at Rolling Out Café at 1722 Taraval Street (near 27th Avenue) on September 19th from 6:30pm-8:00pm. Economic development includes workforce development, business attraction and retention, beautification, art and culture, and neighborhood commercial revitalization in District 4.

### Transit Effectiveness Project Draft Environmental Impact Report Available By: Yelena Gankin, District 4 Intern

n July 10, the City and County of San Francisco published a draft of the Environmental Impact Report (EIR) for the Transit Effectiveness Project (TEP). The SFMTA conducted a comprehensive evaluation of transit service that examined route and line performance, travel time, reliability, and ridership throughout the Muni system. The proposed transit service changes impacting District

4 include:

- Change to the midday frequency of the **28 and 28L** lines from 12 to 9 minutes;
- Change to the midday frequency of the **71L** from 12 to 10 minutes;
- Stop consolidations for the **28L**, with the line operating 7 days a week from 6am to 9pm
- Proposed travel reduction times for the L-Taraval and the N-Judah at various locations
- Elimination of stops along Lake Merced Boulevard between John Muir Drive and Font Boulevard on the **18 line.**

The EIR discloses environmental impacts on the city of San Francisco as a result of changes by the project. Impacts considered include noise, air quality, and transportation and circulation. The EIR also includes mitigation measures and project alternatives. The San Francisco Planning Department is currently accepting comments

# Legislative Update: Massage Establishment Enforcement



**O**n July 30, Supervisor Tang introduced legislation designed to address enforcement issues with massage parlors in our city. For years, our office has heard from the community about potentially illegal activity taking place in some of our massage parlors in our district. We have also seen blatant advertisements in newspapers, highlighting some of the alternative services that one can receive at our local massage establishments. Our office then conducted an informal survey of massage parlors located in the Sunset District, and have found at least 30 such establishments operating in our district alone.

Regardless of whether these establishments are operating in compliance with local, state or federal laws, this is an enormous over-concentration for this type of use in our neighborhood. Additionally, a relatively recent addition to state law from 2008 limited the ability of local governments to regulate massage establishments if all of the therapists in a massage establishment are certified under the California Massage Therapy Council, which is a voluntary licensing program. Supervisor Tang believes that current state law regulating the massage industry has created many loopholes in terms of enforcement, and several other jurisdictions throughout California are also coming to this realization.

Through this legislation, our office hopes to accomplish two things: 1) codify penalties for violations of health codes concerning massage parlors. What we found is that current penalties are only recommendations and not actually codified in the public health code; and 2) introduce additional regulations concerning massage parlor operations that are allowable under state law.

These additional regulations include:

- Requiring massage practitioners licensed by the Department of Public Health to wear a photo identification card;
- Authorizing denial of a massage establishment permit to an applicant who has been convicted of specified crimes and providing for a subsequent appeal process for anyone denied a permit;
- Prohibiting sexual activity, and consumption of alcohol and non-prescription drugs on the premises of a massage establishment during business hours;
- And providing other health and safety requirements

When drafting the legislation, we took into consideration the safety concerns of potential victims of human trafficking. We also wanted to respect establishments that are operating in compliance with local, state and federal laws.

This legislation is just a small component of a larger discussion that Supervisor Tang is participating in with our city departments to figure out how we as local government can do our part to better help address the issue of human trafficking.

The legislation will next be considered at a committee hearing following legislative recess in the fall prior to being voted on by the full Board of Supervisors.

# Supervisor Tang Honors Local Principals

n July, our office honored a pair of outstanding principals, **David Wong, of Francis Scott Key Elementary School, and Beverly Dobrus, of Lawton Alternative School,** at the July 9<sup>th</sup> Board of Supervisors meeting for their many years of outstanding service to our youth and the community. Mr. Wong has received a promotion to Assistant Superintendent of Elementary Schools for the San Francisco Unified School District (SFUSD), while Mrs. Dobrus has retired after 40 years of service as an educator.

**Mr.Wong** leaves Francis Scott Key after thirteen years of great achievements. Under his leadership, the school has received seven Title I Achievement Awards, awarded to schools that have demonstrated success in closing the achievement gap between high and low-performing students. Mr. Wong has also consistently worked hard in bringing new technology to the school, with FSKey receiving not only a new computer lab for the school, but also having interactive white boards installed in every classroom. However, Mr. Wong's creativity and helpfulness extend beyond the classroom, as he has created opportunities for students to participate in afterschool activities to help expand their social experiences inside and outside the classroom. Mr. Wong also initiated a food pantry to provide economically-disadvantaged families access to more healthy foods. In 2011, Mr. Wong received the Mayor's Principal of the Year Award, which serves as a testament to his outstanding ability to promote student achievement, accountability, equity, and access in the classroom.

**Mrs. Dobrus** leaves Lawton Alternative after twelve years of great accomplishments as well. During Mrs. Dobrus' tenure as Principal, Lawton was awarded a California Distinguished School Award, given to exemplary and inspiring schools in the state. Mrs. Dobrus has also brought a multitude of activities for Lawton students to grow in and enjoy, such as expanding athletic programs, bringing in more arts programs, implementing the Lawton-First Tee Golf Program, forging relations with the YMCA to bring programs to the school, and starting before and after-school Mandarin teaching programs. In 2009, Mrs. Dobrus was awarded the Assembly District 12 Woman of the Year Award for her outstanding service to the Lawton community.

Although we are sad to lose two outstanding District 4 Principals, we are grateful for their contributions to our school community and neighborhood. Mr. Wong and Mrs. Dobrus have enriched the lives of many students and families, and we extend our deepest appreciation to them for their years of service.

# Pathway to Citizenship Initiative

In July, Mayor Lee announced the Pathway to Citizenship Initiative. Through this three-year public private partnership, the City will work with social service providers, including Self Help for the Elderly, to reach out to at least 25,000 citizenship-eligible residents in the San Francisco. There are an estimated 100,000 known citizenship-eligible residents in the Bay Area. Many of these residents are unaware of the services available to them.

The citizenship process can be difficult to navigate and can be burdensome for those who have language barriers. The goal of the program is to reach out to eligible residents and offer free naturalization workshops, legal advice, and translation assistance. This initiative endeavors to support our communities by enhancing economic opportunities, access to education and health care, creating stability for families, and improving civic participation. # Update on **Sloat Boulevard Projects**

project from the 2009 Bike Plan aimed at reducing speeding and improving pedestrian safety at Sloat Boulevard between Skyline and the Great Highway is currently underway through the San Francisco Municipal Transit Agency. This project includes the creation of bike lanes, the removal of a lane of travel in both the eastbound and westbound directions, and the installation of higher visibility continental crosswalks.

This project is one of several designed to make Sloat Boulevard a safer place for pedestrians, bicyclists and motorists. In 2012, Caltrans created a road diet by reducing traffic lanes in both directions from 19<sup>th</sup> Avenue to Everglade. In addition to the road diet, bike lanes were also added. The Department of Public Works has also been working on the Sloat Boulevard Pedestrian Safety Project (details here: <u>www.sfdpw.org/index.aspx?page=1688</u>). This project includes pedestrian refuges, bulb-outs, pedestrian countdown signals, accessible curb ramps, streetlights, and a new mast-arm traffic signal that can be activated by pedestrians.

In addition to this project, the SFMTA began construction of bike lanes on the City portion of Sloat Boulevard between Skyline and the Great Highway. This is a project from the 2009 Bike Plan that will reduce speeding and make pedestrian crossings of Sloat easier by removing an unneeded travel lane from each direction and adding a bike lane. Higher visibility continental crosswalks are also planned for installation.

# Upcoming Improvements to Sunset Green Space

### West Sunset Field

n 2012, voters passed Proposition B, the **Clean and Safe Neighborhood Park Bond Project**. This gives the Recreation and Park Department an additional \$195 million to continue capital projects for the renewal and repair of our parks, recreation and open space assets. The 2012 Bond includes funding for 15 neighborhood parks, improvements to Golden Gate Park, McLaren Park and Lake Merced , as well as renovations to the parks' support infrastructure.

One of the neighborhood parks slated to be improved is West Sunset Playground, located between Sunset Elementary School and A.P. Giannini Middle School at Ortega and Quintara Streets. This project, with \$13.2 million in funding, may include renovation of sports courts, natural turf fields, including the bleachers, storage facility, restrooms, support space, and related park amenities. ### Sunset Boulevard Greenway

he Public Utilities Commission is currently working on upgrading San Francisco's sewer infrastructure with the **Sewer System Improvement Program (SSIP)**. San Francisco's combined sewer system is 100 years old; and with an 80% chance that an earthquake of 6.0 magnitude or higher will impact us within the next 20 years, the City is upgrading the sewer system to ensure the overall vitality of our City's public health and the environment. Improvements are in three areas:

**GREY:** Upgrade critically aging and seismically vulnerable grey infrastructure like pump stations and treatment facilities.

**GREEN:** Build innovative green infrastructure to reduce stormwater flows into our sewer system while enhancing neighborhoods.

**CLEAN:** Ensure that only treated water will be released into the Bay and Pacific Ocean protecting the health of our community and the environment.

One of the GREEN improvements will be to Sunset Boulevard.Wide streets with large landscaped areas provide ample opportunity to improve stormwater management. Improvements to Sunset Boulevard may feature rain gardens, trail improvements, beautification, habitat enhancements, public education, and opportunities for youth. Currently, this project is in the planning phase. A community open house was held on July 25. Design will begin in spring of 2014, and construction will be complete by late 2016.
