If the legislation passes, the following existing fees shall be codified to reflect the current standard rates as calculated by the City Controller, as follows:

- Application fee for a massage establishment \$394 to \$658
- Annual license fee for a massage establishment \$694 to \$1,173
- Application fee for a solo practitioner massage establishment \$394 to \$480
- Application fee for an outcall massage services permit \$278 to \$480
- Annual license fee for an outcall massage service \$231 to \$579

The Annual license fee for a solo practitioner massage establishment shall also be codified to reflect the current standards rates as calculated by the Controller (\$464 to \$579), but it will also be applied to massage establishments where all practitioners are certified by the California Massage Therapy Council. In accordance with San Francisco Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments to the City prior to the time the hearing begins. These comments will be made a part of the official public record and shall be brought to the attention of the Members of the Committee.
