### Castro In-Law Legislation

Last year, as part of a broader effort to address our city's housing crisis, I introduced legislation to legalize the construction of new in-law units in the Castro. In-law units are the most affordable type of non-subsidized housing and tend to be more accessible than other housing stock, since they are typically on the ground floor. The Planning Commission recently voted unanimously to support the legislation, and the proposal has earned supportive editorials from the Bay Area Reporter and the San Francisco Examiner. The legislation will now to go the Board of Supervisors for consideration.

### Utility Box Legislation

During a hearing last year that I held on our process for placing utility boxes on our neighborhood sidewalks, I announced that I'm working on legislation to set clearer and more proneighborhood standards for allowing these boxes. While state law requires that we allow utilities to place their boxes on our sidewalks, we have the power - and the obligation - to ensure that the process is consistent with the needs of our neighborhoods, and with walkability and safety concerns. The legislation is almost complete. I anticipate introducing it shortly.

### **Transportation Updates:**

### Muni Performance Hearing

Muni has many challenges, including \$2.2 billion in deferred maintenance. We need to shore up the system to meet the needs of current residents, while also expanding the system's capacity to match our current and projected population growth. We can't afford to allow Muni to languish. Last year, I held a <a href="hearing">hearing</a> on Muni's performance and requested that the agency provide quarterly reports tracking the system's performance, in order to keep riders updated on how the system is progressing. These reports have provided useful details on service delivery, vehicle availability, on-time performance, extended line delays, bus crowding, and the economic impact of service disruptions on city productivity. Given recent exacerbated problems with the subway's performance, I'll be convening a hearing next month to hear Muni's explanations about the subway's continuing challenges and what the agency is doing to address them.

# Transit Effectiveness Project (TEP)

MTA recently held a community meeting at the LGBT Center on the TEP, under which Muni is proposing to make changes to various routes in order to improve the system's performance to better align routes with riders' needs. The TEP has generated quite a bit of discussion around a number of lines, including the 35 and 48 lines. After meeting with numerous Glen Park and Diamond Heights residents, Muni has revised its proposal for the 35, so that the line can still reach Glen Park BART Station without cutting Moffitt and nearby streets out of the route. Muni is continuing the discussion with residents around proposed changes to the 48 line. More information about the TEP and how to be involved <a href="here">here</a>.

### Transit Funding Lobby Trip to Washington, DC

I have the honor of representing San Francisco on the Metropolitan Transportation Commission (MTC), the Bay Area's regional transportation funding and planning agency. Last week, I joined several of my fellow MTC Commissioners and MTC staff, as well as representatives from other transit agencies, to travel to Washington to meet with members of Congress and their staff about the critical need to ensure adequate federal transit funding. The trip was productive but also a sobering reminder of the dysfunctionality in our nation's capital. I will continue to be a staunch advocate - locally and at the state and federal levels - for strong investment in our transit systems, which are the backbone of our region's economy, environment, and quality of life.

### Proposed F Market Fare Hike

MTA recently proposed <u>raising the fare on the F Market line</u> to as high as \$6 a ride. This idea disregarded the critical role the F plays for everyday Muni riders who use it commute from the Castro to downtown and along the Embarcadero. Indeed, the F is the only surface transportation from the Castro to downtown and plays an important back-up role when the subway melts down. Supervisor David Chiu and I wrote a letter to MTA opposing the idea. Last week, <u>MTA announced that it is abandoning the idea</u>, which is a great result. Following is the letter:


#### Soda Tax Update

Last year, I, along with several colleagues, introduced a proposal to tax soda and other sugary beverages to address our exploding type 2 diabetes epidemic, with proceeds of the tax dedicated to nutrition, physical activity, and health programs in public schools and elsewhere. A <a href="new study">new study</a> from researchers at Stanford and Cornell confirms what research at UCSF and other institutions have been saying for years: that a tax on sodas and other sugary beverages will reduce consumption and thus improve public health.

To better understand the impacts of type 2 diabetes in our city, I've <u>called a hearing</u> where medical providers and city departments will report on the causes, prevalence, impacts and costs of diabetes, particularly in relation to the consumption of soda and other sugary beverages. Healthcare providers, who see firsthand the effects of diabetes in hospitals and examination rooms, will detail the human cost of this disease. Additionally, these providers will address the

long-term economic impacts on medical costs with current and projected diabetes rates. We know that diabetes and other diseases caused by consumption of these beverages hit low-income and minority communities the hardest. Here's <u>a fantastic (and scary) video</u> featuring Oakland Youth Poet Laureate Obasi Davis describing how these drinks are marketed to his community. There will also be a Town Hall meeting hosted by St. Mary's Medical Center and the San Francisco Medical Society on the soda tax next Monday, March 24th at 6 PM at St. Mary's Hospital at 2250 Hayes Street in Morrissey Hall. Raising awareness about this issue is important, since the beverage industry is already spreading misinformation in order to protect its bottom line. A full 8 months before the November election, residents are already receiving mailers, push polls, and robo-calls claiming that the cost of a can of soda is somehow related to the rise in evictions. As we move through the legislative process, we will work hard to ensure that decisionmakers and residents have accurate information about the significant health problems that these beverages are causing for our city and our country.

# Waterfront Ballot Initiative Analysis

The proposed ballot measure to require voter approval of any development project that exceeds current height limits on Port of San Francisco property will change development on our waterfront, if it passes. To ensure that voters have full information about the impacts of this measure, I introduced a resolution asking for an impartial, multi-departmental study of the intiative. I believe the public deserves all information needed to make an informed decision at the ballot box, whatever one's view on the measure. Unfortunately, some of the proponents of the ballot measure don't agree that the public deserves this full analysis and are <u>fighting my efforts to obtain it</u>. If this measure may impact the production of housing (including affordable housing) and

infrastructure investment, the public should be aware of those impacts in order to make as informed a decision as possible.

### **Beginning of the Budget Process**

I have the honor of again serving as a member of the Budget and Finance Committee. We recently began meeting as part of our annual budget process. Among my priorities this year are to protect funding for HIV services - including backfilling federal HIV cuts - beefing up our ability to clean and maintain our public spaces, ensuring adequate resources for Animal Care & Control, providing strong infrastructure and affordable housing investment, and generally making sure that our budget stays on track to fund critical city services while also putting away funds for a rainy day. The budget process is never an easy one, but it is incredibly important for our city's future.

# **Community Updates**

It's been an exciting month in District 8, with four major steps forward:

### Streetlight Improvements in Glen Park and on Guerrero Street

In December of last year, I coordinated a walking tour of Glen Park with members of the Glen Park Association, the PUC and PG&E to address the lack of acceptable street lighting in the neighborhood. As a result, the PUC will present its plans to increase the number of streetlights in Glen Park at the next GPA meeting on April 9th (see Calendar section below for more details). Please join me on the 9th to participate in the PUC's presentation and to offer feedback on the proposed streetlight installations. Additionally, I'm happy to announce plans to upgrade the streetlights along Guerrero Street (between Market Street and San Jose Avenue) to LED lighting. This is great news for the neighborhood, as LED lights last longer, are more energy-efficient and provide a whiter light akin to moonlight. To see an example, go over to Cesar Chavez Street where these lights were installed as part of the streetscape project. The PUC plans to install the LED lights in July.

# Castro Sidewalk Widening Groundbreaking

Last week I joined city officials and Castro neighborhood leaders and residents for a celebration at Jane Warner Plaza to mark the official groundbreaking of the Castro Streetscape and Sidewalk Widening project. This project is a visionary one for the neighborhood, and I'm proud to have championed it and worked closely with the community and city staff to make it a reality. It will be completed in two phases, with the first phase completed by mid-June and the second in October. There will be a construction moratorium the last two weeks of June to accommodate the Frameline Film Festival, Pink Saturday, and Pride events. #### **Guerrero Median Greening**

In late February, I co-hosted a community meeting with the Department of Public Works, the San Jose/Guerrero Coalition, and neighbors to discuss greening the Guerrero street medians between 20th and Market Street. I look forward to working with the community and city staff to making this vision a reality. The next step forward is to organize each of the blocks. As part of that process, we need to identify (a) who lives on or adjacent to what block and (b) which neighbors will volunteer as Block Captains for each block. The responsibility of the Block Captains will be to act as liaisons between the neighbors and the city. We currently need two captains for each of the 8 un-greened blocks between 20th Street and Market. Please provide Adam with your block and whether you are willing to serve as a Block Captain. We will create an organizing spreadsheet and then work with the captains. Please feel free to pass this information onto your neighbors who may not be on our distribution list so that we can ensure strong neighborhood participation.

# **Dolores Park Groundbreaking**

Early this month, we <u>officially broke ground</u> on the Dolores Park Renovation project. The renovation is funded by the 2008 parks bond and resulted from more than a year of community design meetings in which hundreds of residents participated. Dolores Park is a civic gem, but it's worn down. Its irrigation and drainage systems are defunct, it doesn't have enough restrooms, and its paths are not accessible. The renovations will include new irrigation and drainage systems, refurbished tennis courts, new restrooms and elimination of the existing restroom building (tripling restroom capacity), and accessible paths. During construction, at least half of the park will remain open at all times. The northern portion of the park is now closed, and will remain so through fall 2014. # 24th Street Urban Village Streetscape Project Update

On January 23, 2014, over 40 community members convened at St. Philip Parish to provide feedback on proposed streetscape designs for 24th Street. The Department of Public Works, with guidance from my office, MTA, and community input from last year, proposed bulb-outs and decorative crosswalks to the 24th Street streetscape. Bus-bulbs will be installed at the intersections of Noe and 24th Streets and Castro and 24th Streets. Decorative, high-visibility crosswalks will be installed on the Church Street, Noe Street, and Sanchez Street intersections along 24th Street. This project will improve pedestrian safety, transit efficiency, and neighborhood aesthetics, as well as spotlight 24th Street as a transit and community hub. Currently, DPW is creating construction documents for the project. The drawings are expected to be completed by summer, and construction to finish this Fall.

### Glen Canyon Re-Opening

We held a ceremony to mark the reopening of the recreation facilities in Glen Canyon. Glen Canyon now has new tennis courts, a new playground, and a dramatically improved entrance from Elk Street. These improvements - funded by the 2008 Parks Bond - are a great first step to an improved the park. We are now in the planning process for renovating the entire recreation center, which is in awful condition. 
