Discontinue the 81X-Caltrain Express, weekday peak period 80X service would be removed from Third, Market, Beale, Folsom, The Embarcadero, Townsend, Fourth and King.

Revise the 82X-Levi Plaza and Presidio Express to operate (weekdays, peak periods only) on a revised AM peak period route and to operate on the same PM peak period route as it does now. It would no longer operate on The Embarcadero between Folsom and Broadway and on Broadway between The Embarcadero and Front in the AM peak period. As with 80X, the schedule would also be revised.)

In general the rule shall not apply to hearings to consider subject matter when no legislation has been presented. nor shall the rule apply to resolutions which simply **urge** action to be taken.
