3 **Motion concurring in the September 11, 2001 Declaration of the Existence of a Local**
4 **Emergency for Limited Purposes by the Mayor, in the actions taken to meet the**
5 **emergency, and in the termination of the emergency.**

7 WHEREAS, On September 11, 2001, Mayor Willie L. Brown, Jr. declared a local
8 emergency to exist for certain limited purposes in connection with the terrorist attacks that
9 occurred in the eastern United States that morning; and,

10 WHEREAS, Government Code Sections 8550 et seq. and Charter Section 3.100
11 provide for the concurrence by members of the Board of Supervisors in such emergency
12 declaration and in action taken by the Mayor to meet the emergency; and

13 WHEREAS, The Mayor authorized all appropriate measures relating to the closure of
14 the courts on September 11, 2001, all appropriate measures relating to the release and
15 deployment of City personnel on September 11, 2001, and all appropriate measures relating
16 to the closure of public schools in the City and County of San Francisco on September 11,
17 2001; and

18 WHEREAS, The Mayor terminated the declaration of local emergency on September
19 12, 2001; and

20 WHEREAS, In declaring the existence of the local emergency and in terminating the
21 emergency, the Mayor consulted with the President of the Board of Supervisors, as well as
22 with other members of the Board who were available, and they concurred in such actions;
23 now, therefore, be it
