8 hereby appoint the hereinafter designated persons to serve as a members of the Shelter
9 Monitoring Committee, pursuant to the provisions of Ordinance No. 283-04 and Article XII of
10 Article 20 of the San Francisco Administrative Code, for the terms specified:

11 Rita P. Lark, new assignment, seat 1, must be homeless or formerly homeless within
12 the 3 years prior to appointment and living with their homeless child under age 18, for two-
13 year term ending November 23, 2010.

14 Elihu Hernandez, new assignment, seat 2, must be homeless or formerly homeless
15 within the 3 years prior to appointment with a disability, for two-year term ending November
16 23, 2010.

17 Aubrey Moore, succeeding Chris Callandrillo, seat 3, term expired, must have
18 experience providing direct services to the homeless through a community setting, for two-
19 year term ending November 23, 2010.

20 Ramses Teon-Nichols, succeeding Kim Clark, seat 4, term expired, must be selected
21 from a list of candidates that are nominated by community agencies that provide behavioral
22 health, housing placement, or other services to the homeless, for two-year term ending
23 November 23, 2010.

24 Diana Greer, succeeding Diana Greer, seat 5, term expired, must be selected from a
25 list of candidates that are nominated by non-profit agencies that provide advocacy or

organizing services to homeless people and be homeless or formerly homeless, for two-year term ending November 23, 2010.

Amanda Thompson, succeeding Damian Ochoa, seat 6, term expired, must be selected from a list of candidates that are nominated by non-profit agencies that provide advocacy or organizing services to homeless people, for two-year term ending November 23, 2010.
