15 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional  
16 organization, or Property Appraiser certified by the Office of Real Estate Appraiser; or he or  
17 she is a current member of an assessment appeals board, for the unexpired portion of a  
18 three-year term ending September 7, 2012.
