12 the Budget and Finance Committee on July 17, 2013, in which Harvey M. Rose Associates,
13 LLC, Debra A. Newman, Louie & Wong, LLP, a Joint Venture received the highest number of
14 points; now therefore, be it

15 MOVED, That the Board of Supervisors authorizes and directs the Clerk of the Board
16 of Supervisors to commence negotiations with Harvey M. Rose Associates, LLC, Debra A.
17 Newman, Louie & Wong, LLP, a Joint Venture for Budget and Legislative Analyst Services per
18 RFP # BOS-01-425, and, if those negotiations do not produce an agreement, to commence
19 negotiations with the next-highest bidder under the RFP; now therefore, be it

21 the Board of Supervisors to enter into a Professional Services Agreement for Budget and
22 Legislative Analyst Services with Harvey M. Rose Associates, LLC, Debra A. Newman, Louie

24 2.117.


