2 AMENDING ARTICLE 3 OF PART III OF THE SAN FRANCISCO MUNICIPAL CODE
3 (BUSINESS AND TAX REGULATIONS CODE), BY ADDING SECTION 258 TO SUSPEND
4 APPLICATION OF LICENSING AND OTHER REQUIREMENTS FOR TRANSIENT
5 MERCHANTS.

9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Article 3 of the San Francisco Business and Tax Regulations Code is
12 hereby amended by adding Section 258, to read as follows:

13 **SEC. 258. SUSPENSION OF LICENSING AND OTHER REQUIREMENTS.**

14 (a) Notwithstanding the other provisions of this Article, no transient merchant shall be
15 required to (i) apply for a license under Section 252, (ii) obtain a license under Section 250, or
16 (iii) file a bond under Section 255, during the suspension period provided in subsection (b).

17 (b) The suspension period shall be that period commencing on the effective date of
18 this ordinance and ending thirty (30) days after its repeal.


