10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The City Attorney is hereby authorized to settle the action entitled "Alliance
12 Financial (a California partnership) and Alliance Financial Capital, Inc., v. City and County of
13 San Francisco, et al., Superior Court for the County of Alameda, Court No. 759149-9, by the
14 payment of \$130,000 (one hundred thirty thousand dollars).

15 Section 2. The above-named action was filed in the Superior Court for the County of
16 San Mateo on July 7, 1995 and then transferred to the Superior Court for the County of
17 Alameda, and the following parties were named in the lawsuit: plaintiffs are Alliance Financial
18 (a California partnership) and Alliance Financial Capital, Inc.; defendants are the City and
19 County of San Francisco and Does 1-20, inclusive.






