11 Section 1. The San Francisco Elections Code is hereby amended by deleting Section  
12 586 in its entirety.


16 ~~When an argument is submitted by the Board of Supervisors for publication in the voter~~  
17 ~~information pamphlet, the Clerk of the Board of Supervisors shall forward to the Director of Elections a~~  
18 ~~list of the Supervisors who voted for and a list of the Supervisors who voted against submission of the~~  
19 ~~argument. Immediately following the argument in the voter information pamphlet, the Director of~~  
20 ~~Elections shall publish a statement disclosing the name of each Supervisor who voted for and against~~  
21 ~~submission of the argument. The text of this statement, including the names of the Supervisors, shall~~  
22 ~~not be counted toward the word limits specified in Sections 575 and 550(a) of this Article.~~


