3 **Ordinance repealing the San Francisco Fire Code and adopting, in its entirety, a new**
4 **San Francisco Fire Code.**

5 Note: This material is entirely new.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The San Francisco Fire Code is hereby repealed in its entirety.

9 Section 2. A document, three copies of which are on file in the office of the Clerk of the
10 Board of Supervisors of the City and County of San Francisco, being marked and designated
11 as the "2001 San Francisco Fire Code" is hereby adopted as the Fire Code for the City and
12 County of San Francisco.

13 Section 3. Nothing contained in this or the preceding sections shall be construed as
14 abating any action now pending under or by virtue of any ordinance of the City herein
15 repealed; or as discontinuing, abating, modifying or altering any penalties accruing, or to
16 accrue, or as waiving any right of the City under any ordinance in force at the time of passage
17 of this ordinance regulating the hazards of fire and explosion arising from the storage,
18 handling and use of hazardous substances, materials and devices, or from conditions
19 hazardous to life or property in the use or occupancy of buildings or premises.

20 Section 4. If any section, subsection, subdivision, paragraph, sentence, clause or
21 phrase of this ordinance or any part thereof is for any reason held to be unconstitutional or
22 invalid, such decision shall not affect the validity of the remaining portions of this ordinance or
23 any part thereof. The Board of Supervisors hereby declares that it would have passed each
24 section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of

1 the fact that any more sections, subsections, subdivisions, paragraphs, sentences, clauses or
2 phrases be declared unconstitutional or invalid or ineffective.

3 Section 5. This ordinance shall take effect and be in full force from and after November
4 1, 2002.
