[Motor Vehicle for Hire Permit Filing Fees and License Fees]

**Ordinance amending Sections 2.26.1 and 2.27.1 of the Police Code to amend schedules for motor vehicle for hire permit filing fees and license fees.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Police Code is hereby amended by amending Section 2.26.1, to read as follows:

Sec. 2.26.1. SCHEDULE OF PERMITS AND FILING FEES.

Notwithstanding the provisions of Section 1085 of this Code, the following filing fees, payable in advance to the ~~Police Department~~ Taxi Commission, are required when submitting applications for Motor Vehicle for Hire permits to the ~~Police Department~~ Taxi Commission:
