13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Traffic Code is hereby amended by amending  
15 Section 71b, to read as follows:

16 **Section 71b. Towing of Vehicles Obstructing the Normal Flow of Traffic**

17 Any vehicle parked or stopped in violation of Subdivision (a) of Section 32, Section 38.B, Section  
18 38.B.1, Section 33.3, Section 33.3.2, Section 39, Section 62A, Section 66, or Section 71 of this  
19 Article shall be deemed to be left standing on a street in an unusual position and obstructing the  
20 normal movement of traffic thereof. Such vehicle shall be subject to removal under the provisions of  
21 Section 22651(b) of the Vehicle Code of the State of California.


