9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this  
12 Ordinance are in compliance with the California Environmental Quality Act (California Public  
13 Resources Code sections 21000 et seq.).

14 Section 2. The San Francisco Park Code, Article 12, is hereby amended by adding  
15 Section 12.35 to read as follows:

16 Sec. 12.35. TINY TOT/CHILD DEVELOPMENT PROGRAM FEES.

17 The following fees shall be charged for the Department's Tiny Tot/Child Development Program:

- 18 (a) Traditional Tiny Tots \$30.00 for 10 visits
- 19 (b) Play Groups \$3.00 for drop in or \$20.00 for 10 visits
- 20 (c) Kids Gym \$4.00 for drop in or \$30.00 for 10 visits
- 21 (d) Arts and Crafts \$4.00 for drop in or \$30.00 for 10 visits
- 22 (e) Special Programs \$3.00 for drop in or \$20.00 for 10 visits


