9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et seq.).

14 Section 2. The San Francisco Park Code, Article 12, is hereby amended by adding
15 Section 12.34 to read as follows:

16 Sec. 12.34. AQUATIC FEES.

17 The following fees shall be charged for use of aquatic facilities and other aquatic related
18 activities.




