11 Section 1. The San Francisco Traffic Code is hereby amended by amending
12 Section 175.20, to read as follows:

14 A prima facie speed limit of 30 miles per hour is hereby established on The
15 Embarcadero between ~~Berry King~~ King Street and Broadway.

16 Section 2. The San Francisco Traffic Code is hereby amended by amending
17 Section 176.39, to read as follows:

18 SEC. 176.39.

19 A prima facie speed limit of 35 miles per hour is hereby established on King Street,
20 between ~~3rd and 5th Streets~~ 5th Street and The Embarcadero.
