Findings The Planning Department has determined that the actions contemplated in this 10 Ordinance are in compliance with the California Environmental Quality Act (California Public 11 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the 12 Board of Supervisors in File No. 090697 and is incorporated herein by reference. 13 Section 2. The San Francisco Police Code is hereby amended by amending Section 2404.1, 14 15 to read as follows: 16 SEC. 2404.1. STREET ARTIST CERTIFICATE: FEE. 17 Pursuant to the provisions of Proposition K, adopted by the voters at an election held on 18 19 November 8, 1983, the Board of Supervisors hereby establishes the fee for a Street Artist Certificate to 20 be as follows: Beginning July 1, 2008 July 1, 2009, the fee for a quarterly Street Artist Certificate shall 21 be \$133.07 <u>\$154.16</u> and said certificate shall be valid for a period of three months from the date of 22 issuance; except that any person certified as a street artist pursuant to the provisions of this Article shall 23 have the option of purchasing for \$532.28 \$616.64 an annual certificate valid for a period of one year 24 from the date of issuance. 25
