

1 [Revising Board of Appeals Surcharges]

3 **Ordinance amending San Francisco Administrative Code, Chapter 10G, Section 10G.1**  
4 **to adjust the surcharges on permit fees, license fees, permit review fees and permit**  
5 **and license renewal fees imposed by the Department of Building Inspection, the**  
6 **Planning Commission, the San Francisco Municipal Transportation Agency Board of**  
7 **Directors, the Department of Public Works, the Entertainment Commission, and the**  
8 **Department of Public Health for permits and licenses that may be appealed to the**  
9 **Board of Appeals; remove the surcharge imposed by the Art Commission for Street**  
10 **Artist Certificates; and making environmental findings.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The San Francisco Administrative Code is hereby amended by amending  
16 Section 10G.1, to read as follows:

17 **SEC. 10G.1. SURCHARGE IMPOSED; CATEGORIES OF PERMITS AND FEES.**

18 In order to recover the cost to the City and County for the Board of Appeals permit  
19 review functions, at the time a fee for permit application, issuance, or review is collected, and  
20 at the time an annual fee for renewal of the permit or license associated with the permit is  
21 collected, a surcharge in the amount specified shall be charged and collected for the following  
22 categories of permits and fees.

23 (a) For fees imposed by the Department of City Planning pursuant to San Francisco  
24 Planning Code Sections 351(h), 352(a) (except for fees imposed for hearings on Conditional  
25 Uses under Section 303 or Planned Unit Developments under Section 304), 353(a), 353(b),

1 353(c), or 355 for review of permits that may be appealed to the Board of Appeals pursuant to  
2 Charter Section 4.106, a surcharge of ~~\$22.50~~\$25.00;

3 (b) For permits issued pursuant to San Francisco Building Code Section 110A:  
4 Tables 1A-A; 1A-F, Item 3; 1A-H; 1A-K, Item 8; or 1A-Q, Item 5; that may be appealed to the  
5 Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$22.50~~\$25.00;

6 (c) For permits issued pursuant to the San Francisco Public Works Code that may  
7 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of  
8 ~~\$4.50~~\$6.00;

9 (d) For permits specified in San Francisco Police Code Section 2.26 that may be  
10 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of \$26.50  
11 for such permits issued by the Police Department, and a surcharge of ~~\$3.00~~\$4.00 for such  
12 permits issued by the Entertainment Commission;

13 (e) For permits specified in San Francisco Police Code Section 2.26.1 that may be  
14 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of  
15 ~~\$3.50~~\$7.00;

16 (f) For annual license fees specified in San Francisco Police Code Section 2.27 for  
17 permits that may be appealed to the Board of Appeals pursuant to Charter Section 4.106, a  
18 surcharge of \$26.50 for such permits issued by the Police Department and a surcharge of  
19 ~~\$3.00~~\$4.00 for such permits issued by the Entertainment Commission;

20 (g) For annual license fees specified in San Francisco Police Code Section 2.27.1  
21 for permits that may be appealed to the Board of Appeals pursuant to Charter Section 4.106,  
22 a surcharge of ~~\$3.50~~\$7.00;

23 (h) For permits issued pursuant to San Francisco Health Code Section 1009.53 that  
24 may be appealed to the Board of Appeals pursuant to Charter Section 4.106, and annual  
25

1 permit fees pursuant to San Francisco Health Code Section 1009.54 and Business and Tax  
2 Regulations Code Section 249.16, a surcharge of ~~\$24.00~~\$51.00;

3 ~~(i) For quarterly or annual certificates issued pursuant to San Francisco Police Code~~  
4 ~~Sections 2404.1 and 2408(a) that may be appealed to the Board of Appeals pursuant to Charter Section~~  
5 ~~4.106 and San Francisco Police Code Section 2409, a surcharge of \$9.00.~~

6 Section 2. The Planning Department has determined that the actions contemplated in  
7 this Ordinance are in compliance with the California Environmental Quality Act (California  
8 Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk  
9 of the Board of Supervisors in File No. 100363 and is incorporated herein by this  
10 reference.




