
2 IMPLEMENTING AMENDMENT NO. 1 TO THE 1998-2001 MEMORANDUM OF
3 UNDERSTANDING BETWEEN THE TEAMSTERS LOCAL 216 AND THE CITY AND
4 COUNTY OF SAN FRANCISCO TO CORRECT CLERICAL OMISSIONS BY: 1) ADDING A
5 PROVISION FOR A MINIMUM PERIOD OF TIME AND RATE OF PAY FOR CERTAIN
6 OVERTIME ASSIGNMENTS; 2) INCORPORATING RULE CHANGES BY THE CITY'S
7 RETIREMENT BOARD REGARDING CREDITING OF ACCRUED SICK LEAVE FOR
8 RETIREMENT PURPOSES; AND 3) ADDING LANGUAGE REGARDING CONTRIBUTIONS
9 TO THE EMPLOYEE TUITION REIMBURSEMENT FUND AS SET FORTH IN
10 MEMORANDUM OF UNDERSTANDING, EFFECTIVE JULY 1, 1999.

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The Board of Supervisors hereby implements the provisions of Amendment
13 No. 1 to the 1998-2001 Memorandum of Understanding between the Teamsters Local 216
14 and the City and County of San Francisco to correct clerical omissions by: 1) adding MOU
15 article III.F (Pre-scheduled Overtime), providing for a minimum period of time and rate of pay
16 for certain overtime assignments; 2 adding MOU article III.O (Retirement), incorporating by
17 reference any future rule changes by the City's retirement board regarding crediting of
18 accrued sick leave for retirement purposes; and 3) adding MOU article III.G (Employee Tuition
19 Reimbursement Program), providing for contributions to the Employee Tuition Reimbursement
20 Fund. The amendment to the Memorandum of Understanding so implemented is on file in the
21 office of the Board of Supervisors.




