2 CREATING UNDERGROUND DISTRICT NO. 354 IN THE OAKDALE, PALOU, AND
3 NEWCOMB AREA.

5 Note: This entire section is new.

6 Be it ordained by the people of the City and County of San Francisco:

7
8 Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X,
9 Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does
10 hereby create the following underground district:

11 Underground District No. 354
12 (Oakdale/Palou/Newcomb District)

13 covering Palou Avenue from the easterly line of Selby Street to the westerly line of Keith Street,
14 Oakdale Avenue from the easterly line of Selby Street to the westerly line of Keith Street, Newcomb
15 Avenue from the easterly line of Phelps Street to the westerly line of Keith Street, Keith Street from the
16 southerly line of Newcomb Avenue to the northerly line of Palou Avenue, Lane Street from the
17 southerly line of Newcomb Avenue to the northerly line of Palou Avenue, Mendell Street from the
18 southerly line of Oakdale Avenue to the northerly line of Palou Avenue, Newhall Street from the
19 southerly line of Newcomb Avenue to the northerly line of Palou Avenue, Phelps Street from the
20 southerly line of Newcomb Avenue to the northerly line of Palou Avenue, Quint Street from the
21 northerly line of Palou Avenue to the southerly line of Oakdale Avenue, Dunshee Street and
22 Drummond Alley all.

23 Section 2. The undergrounding of facilities within this underground district is in the general
24 public interest in that said action will eliminate a heavy concentration of overhead wires.

1 Section 3. All work in connection with the undergrounding of facilities lying within this
2 underground district and subject to the laws with reference to underground districts is to be completed
3 in accordance with the Department of Public Works' program; provided, however, that said work shall
4 be commenced at such time or according to such priority as the Department of Public Works has
5 established.

6 Section 4. The Board hereby requests that the utility companies providing the undergrounding
7 of facilities within this underground district pay for up to 100 feet of each underground service lateral
8 occasioned by the undergrounding.






