WHEREAS, Recent floods and mudslides have resulted in the worst
natural disaster to hit Venezuela this century; and,

WHEREAS, The death toll from the flooding in Venezuela is
estimated at more than 5,000; and,

WHEREAS, An estimated 150,000 people are homeless as a result of
the floods; and,

WHEREAS, More than 40,000 people have been evacuated from
devastated areas hit by torrential rains; and,

WHEREAS, More fluids are needed to treat children suffering from
dehydration and hunger; and,

WHEREAS, Troops are combing the streets and houses for people
who might still be alive under mudslides and rubble; and,

WHEREAS, The magnitude of the disaster has overwhelmed
Venezuela's capacity to respond; and,

WHEREAS, The City of Caracas, Venezuela, is a Sister City of San
Francisco's; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County
of San Francisco extends condolences to the flooding victims in
Venezuela; now, therefore, be it

1 FURTHER RESOLVED, That the Board of Supervisors of the City and
2 County of San Francisco urges each City department to determine how
3 they can assist in the relief efforts currently underway in
4 Venezuela.
