

1 [Airport Lease and Operating Agreements]  
2 APPROVING THE TERMS OF LEASE AND OPERATING AGREEMENTS BETWEEN THE  
3 CITY AND VARIOUS AIRLINES TO ALLOW SUCH AIRLINES TO RELOCATE  
4 INTERNATIONAL FLIGHT OPERATIONS TO THE NEW INTERNATIONAL TERMINAL.

5 WHEREAS, Aeroflot Russian International Airlines, Air China, Air France, Alitalia  
6 Airlines, Asiana Airlines, All Nippon Airways, British Airways, PLC, Cathay Pacific Airways,  
7 LTD, China Eastern Airlines, EVA Airways, Finnair, Korean Air, KLM Royal Dutch Airlines,  
8 Lineas Areas Costarricenses, S.A., Lufthansa German Airlines, Ryan International Airlines,  
9 Swissair Transport Co. LTD, and Virgin Atlantic Airways conduct international operations at  
10 San Francisco International Airport's Central Terminal Building ("CTB"); and,

11 WHEREAS, Pursuant to its Master Plan Expansion Program, the Airport is constructing  
12 a new international terminal building ("ITB") to which, on completion, all international flight  
13 activity currently located in the CTB will relocate; and,

14 WHEREAS, the above referenced Airlines desire to lease from City and City desires to  
15 lease the said Airlines certain premises in the ITB, as described in Attachment A hereto;

16 WHEREAS, The Airport Commission adopted Resolution Numbers 99-0314, 99-0315,  
17 99-0316, 99-0317, 99-0318, 99-3019, 99-0320, 99-0321, 99-0322, 99-0323, 99-0324, 99-  
18 0325, 99-0326, 99-0327, 99-0328, 99-0329, 99-0330, and 99-0331, on September 21, 1999,  
19 approving certain Lease and Operating Agreements between the above referenced Airlines to  
20 allow said Airlines to relocate their international operations from the CTB to the ITB; now,  
21 therefore, be it

22 RESOLVED, That this Board of Supervisors approves Lease and Operating  
23 Agreements between the above referenced Airlines and the City and County of San  
24 Francisco, acting through its Airport Commission, as described in Attachment A hereto,


