

1 [STATE FUNDING FOR SERVICES TO IMMIGRANT COMMUNITIES]

3 URGING THE CALIFORNIA STATE LEGISLATURE TO INCLUDE FUNDING FOR  
4 PROGRAMS WHICH PROVIDE ONGOING SERVICES TO IMMIGRANT COMMUNITIES IN  
5 THE 2000-2001 STATE BUDGET.

6 WHEREAS, On January 10<sup>th</sup>, Governor Davis officially released his proposed 2000-  
7 2001 state budget; and

8 WHEREAS, Although the proposed budget continues to fund most programs for  
9 immigrants, it does not continue to provide benefits for recent immigrants beyond a limited  
10 time- reflecting a lack of ongoing commitment to immigrant needs; and

11 WHEREAS, The \$4.9 million proposed budget for the Healthy Families Program would  
12 allow recent legal immigrant children (post 8/22/96 entrance) who enroll in Healthy Families  
13 by June 30, 2000, to continue receiving Healthy Families through June 30, 2001, the budget  
14 does not provide any funding for legal immigrant children who seek to enroll after June 30,  
2000; and

15 WHEREAS, The \$21.6 million proposed budget for the Cash Assistance Program for  
16 Immigrants (CAPI) does not provide CAPI benefits for recent legal immigrants (post-8/22/96  
17 entrants) beyond the sunset date, September 30, 2000 ; and

18 WHEREAS, The \$51.6 million proposed budget for the California Food Assistance  
19 Program (CFAP) reflects a \$5.8 million reduction and does not allow CFAP to continue to  
20 provide benefits to recent legal immigrants (post 8/22/96 entrants) beyond the sunset date,  
September 30, 2000; now, therefore, be it

21 RESOLVED, That the San Francisco Board of Supervisors urges the California State  
22 Legislature to include funding for programs which provide ongoing services to immigrant  
23 communities in the 2000-2001 state budget.
