

1 [Appointment to Municipal Transportation Agency]  
2 CONFIRMING THE APPOINTMENT OF ENID NG LIM TO THE BOARD OF DIRECTORS OF  
3 THE MUNICIPAL TRANSPORTATION AGENCY FOR A TERM COMMENCING MARCH 1,  
4 2000

5 WHEREAS, Article VIII.A of the City Charter, approved November 1999, establishes  
6 the Municipal Transportation Agency which shall include the Municipal Railway, commencing  
7 July 1, 2000 and the Department of Parking and Traffic, commencing July 1, 2002; and,

8 WHEREAS, The Municipal Transportation Agency shall include a Board of Directors  
9 governed by a board of seven directors appointed by the Mayor and confirmed by the Board  
10 of Supervisors; and,

11 WHEREAS, The Mayor shall designate the initial terms of the directors; and,

12 WHEREAS, Two of the directors shall serve terms ending March 1, 2004, two for terms  
13 ending March 1, 2003, two for terms ending March 1, 2002, and one for a term ending March  
14 1, 2003; and,

15 WHEREAS, At least four of the directors must be regular riders of the Municipal  
16 Railway and must continue to ride the Municipal Railway during their term; and,

17 WHEREAS, The directors must possess significant knowledge of, or professional  
18 experience in, one or more of the fields of government, finance, or labor relations; and,

19 WHEREAS, At least two of the directors must possess significant knowledge of, or  
20 professional experience in, the field of public transportation; and,

21 WHEREAS, The Mayor has appointed Enid Ng Lim to the Board of Directors of the  
22 Municipal Transportation Agency for a term commencing March 1, 2000 and ending March 1,  
23 2003; now, therefore, be it


