

1 [Sustainable Funding for School Arts and Music Task Force]
2 ADDING TWO SEATS TO THE SUSTAINABLE FUNDING FOR SCHOOL ARTS AND MUSIC
3 TASK FORCE: AN AT-LARGE SEAT WHO SHALL BE A TEACHER IN THE SAN
4 FRANCISCO UNIFIED SCHOOL DISTRICT AND AN AT-LARGE SEAT WHO SHALL BE A
5 MEMBER OF AN ARTS ADVOCACY ORGANIZATION.

6 WHEREAS, On December 13, 1999, the Board of Supervisors adopted
7 by unanimous vote Resolution #1127-99, creating a sustainable funding
8 for school arts and music task force to make policy recommendations
9 to the Mayor and the Board of Supervisors of the City and County of
10 San Francisco; and,

11 WHEREAS, This task force is comprised of 20 members, 13 of whom
12 are designated and 7 of whom are at-large representatives; and,

13 WHEREAS, These 20 members include:

- 14 • one (1) member who shall be the Director of the Department of
15 Children, Youth, and Families or his/her designated
16 representative,
- 17 • one (1) member who shall be the Director of the Art
18 Commission or his/her designated representative,
- 19 • one (1) member who shall be the President of the San
20 Francisco Parent Teacher Association or his/her designated
21 representative,
- 22 • one (1) member who shall be the San Francisco Special
23 Projects Officer of the California State Parent Teacher
24 Association or his/her designated representative,

- 25 the San Francisco Unified School District,

- 1 • one (1) at-large member who shall be a teacher in the San
- 2 Francisco Unified School District,
- 3 • one (1) at-large member representing the interests of the
- 4 business community,
- 5 • one (1) at-large member representing the interests of the
- 6 philanthropic community,
- 7 • one (1) at-large member representing a youth advocacy
- 8 organization,
- 9 • one (1) at-large member representing an arts advocacy
- 10 organization; and,

11 WHEREAS, These members are charged with making recommendations
12 to the Mayor and the Board of Supervisors regarding a sustainable
13 funding source for school arts and music programs as well as
14 recommendations on a fiscal body to monitor and distribute funding
15 for school arts and music programs; and,

16 WHEREAS, Great interest was shown in serving on the at-large
17 seats of the task force, particularly from teachers and members of
18 arts advocacy organization; now therefore be it,

19 RESOLVED, That the Board of Supervisors of the City and County
20 of San Francisco hereby adds two seats to the sustainable funding for
21 school arts and music task force: an at-large seat who shall be a
22 teacher in the San Francisco Unified School District and an at-large
23 seat who shall be a member of an arts advocacy organization.




