2 DECLARING THE RESULTS OF THE CONSOLIDATED PRESIDENTIAL PRIMARY
3 ELECTION CONDUCTED ON MARCH 7, 2000, IN THE CITY AND COUNTY OF SAN
4 FRANCISCO.

5 WHEREAS, A Consolidated Presidential Primary Election was conducted in the City
6 and County of San Francisco on Tuesday, March 7, 2000, which placed before the electorate
7 various ballot measures and candidates for election to various offices; and,

8 WHEREAS, The Acting Director of Elections of the City and County of San Francisco,
9 by her letter dated March 24, 2000, has certified to this Board of Supervisors the results of the
10 aforesaid election, which certification is contained in File 000569 of the Board of
11 Supervisors, and which is incorporated herein by reference as though fully set forth; now,
12 therefore, be it

14 certification by the Acting Director of Elections, does hereby, pursuant to Sections 9269 and
