3) No malt beverage shall be sold with an alcoholic content greater than 5.7% by volume. 4) Wine shall not be sold in bottles or containers smaller than 750 ml., and wine coolers shall not be sold in units of less than a four pack. 5) No pay telephone will be maintained on the interior or exterior of the premises. 6) The applicant shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
