COMMENDING THE AVON BREAST CANCER 3-DAY AND ITS EFFORTS TO PROMOTE BREAST CANCER AWARENESS AND PREVENTION.

WHEREAS, Breast cancer ranks just behind lung cancer as the leading cause of cancer death for women; and,

WHEREAS, Breast cancer is the leading cause of cancer death among women in the 15-34 and 35-54 age groups and the second cause of cancer death for women aged 55-74; and,

WHEREAS, Avon Products, Inc. has worked to educate women about breast cancer through its fundraising programs and through the Avon Breast Cancer Crusade, an initiative with a mission of supporting non-profit, community-based breast cancer education and early detection programs; and,

WHEREAS, Avon initiated the Avon Breast Cancer 3 Day in 1998, and since then the walk has become the largest of its kind in the fight against breast cancer; and,

WHEREAS, More than 15,000 walkers have so far participated in the six Avon Breast Cancer 3-Days, and more than \$ 25 million dollars has been raised to fight against breast cancer; and,

WHEREAS, On July 28-30, 2000, more than 2,000 men and women will participate in the 60 mile Avon Breast Cancer 3-Day from San Jose to San Francisco and confirm their commitment to the fight to prevent breast cancer; and,

1           WHEREAS, Net proceeds from the 2000 Avon Breast Cancer 3-Days  
2 will be awarded as grants to support medical research into the  
3 possible causes, prevention, treatment and cure of breast cancer;  
4 educational seminars; support services for breast cancer patients,  
5 survivors and their families; and community-based early detection and  
6 education programs; now, therefore, be it

7           RESOLVED, That the Board of Supervisors of the City and  
8 County of San Francisco hereby commends the Avon Breast Cancer 3-Day  
9 and its efforts to promote breast cancer awareness and prevention.


