11 non-queer audiences alike; and,

12 WHEREAS, The Queer Cultural Center hosts the annual National Queer Arts Festival;  
13 and,

14 WHEREAS, Lou Harrison is a composer, poet, environmentalist, and gay icon known  
15 for his mastery of Eastern and Western music; and,

16 WHEREAS, Lou Harrison has been a vital presence in the contemporary music world  
17 during the last 60 years and he continues to define what a polyglot, cross-cultural, open and  
18 generous musicality can achieve; and,

19 WHEREAS, The National Queer Arts Festival 2000 will host "A Salute to Lou  
20 Harrison" in collaboration with the San Francisco Symphony's American Mavericks festival on  
21 June 15, 2000 at Davies Symphony Hall; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
23 commends the National Queer Arts Festival 2000 and the San Francisco Symphony's  
24 American Mavericks festival for "A Salute to Lou Harrison".


