

1 [Late Bond Measure]
2 SUSPENDING THE MAY 15, 2000 DEADLINE DATE TO PERMIT SUPERVISOR BROWN
3 TO INTRODUCE A PROPOSED GENERAL OBLIGATION BOND MEASURE CONCERNING
4 LIBRARY FACILITIES AND PROPERTIES OTHER THAN THE MAIN LIBRARY IN THE
5 AMOUNT OF \$129,245,000 ON MONDAY, JUNE 5, 2000, FOR POSSIBLE REFERRAL TO
6 THE VOTERS AT THE NOVEMBER 7, 2000 ELECTION.

8 WHEREAS, The election schedule provides that general obligation bond measures
9 shall be introduced by a Supervisor at a regular Board meeting held not less than 176 days
10 prior to the election at which it is to be acted upon by the electors; and,

11 WHEREAS, May 15, 2000, was the deadline for any member of the Board to submit
12 the complete text of a proposed resolution of public interest and necessity for general
13 obligation bond measures for the November 7, 2000 election; and,

14 WHEREAS, On June 5, 2000, Supervisor Brown submitted a proposed bond measure
15 after the May 15, 2000 deadline date for placement on the November 7, 2000 ballot; now,
16 therefore, be it

17 RESOLVED, That the Board of Supervisors of the City and County of San Francisco,
18 hereby suspends the deadline date to permit Supervisor Brown to introduce on June 5, 2000,
19 a proposed general obligation bond measure concerning library facilities and properties other
20 than the main library in the amount of \$129,245,000, for possible referral to the voters at the
21 November 7, 2000 election.




