AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, COMMUNITY SUBSTANCE ABUSE SERVICES TO ENTER INTO A COMBINED NEGOTIATED NET AMOUNT AND DRUG MEDI-CAL AGREEMENT FOR THE TERM JULY 1, 1998, RETROACTIVELY THROUGH JUNE 30, 2001 WITH THE STATE OF CALIFORNIA, DEPARTMENT OF ALCOHOL AND DRUG PROGRAMS IN THE 99/00 AMOUNT OF \$18,228,544 AS A CONDITION OF RECEIVING STATE FUNDS FOR SUBSTANCE ABUSE TREATMENT; HOLDING THE STATE DEPARTMENT OF ALCOHOL AND DRUG PROGRAMS HARMLESS FROM ANY AND ALL CLAIMS RESULTING FROM THE AGREEMENT: AUTHORIZING AND DESIGNATING THE DIRECTOR OF COMMUNITY SUBSTANCE ABUSE SERVICES TO SIGN SAID AGREEMENT AND TO APPROVE CONTRACT AMENDMENTS FOR LESS THAN TEN PERCENT (10%) OF THE CONTRACTED AMOUNT, RESCINDING RESOLUTION NO. 601-98

WHEREAS, Approval of the Combined Negotiated Net Amount and the Drug Medi-Cal Agreement between the State Department of Alcohol and Drug Programs (DADP) and the City and County of San Francisco would (1) enable the City to accept the State DADP's FY 99/00 funding allocation, or NNA, for the provision of substance abuse services in San Francisco, and (2) authorize the State DADP to encumber federal Drug/Medi-Cal funds for the purpose of reimbursing the City for Drug/Medi-Cal services provided by Community Substance Abuse Services (CSAS) service providers in FY 99/00, for a combined total amount of \$18,228,544; and

WHEREAS, The Agreement includes a hold harmless clause which provides that the City will hold the State harmless from (1) any claims and losses resulting to contractors, subcontractors, individuals, firms and corporations furnishing or supplying work services, materials or supplies in connection to the performance of this contract and (2) any claims and

1 losses resulting to any person, firm or corporation who may be injured or damaged in connection  
2 by the City's performance of this contract; and

3 WHEREAS, The Director of Community Substance Abuse Services is designated to sign  
4 the Combined Net Negotiated Amount and Drug Medi-Cal Agreement and approve future  
5 amendments for less than ten percent (10%) of the contracted amount; and, therefore, be it

6 RESOLVED, That the Department of Public Health, Community Substance Abuse  
7 Services is hereby authorized to enter into a Combined Negotiated Net Amount and Drug Medi-  
8 Cal Agreement for the term of July 1, 1998, retroactively, through June 30, 2000 with the State  
9 of California, Department of Alcohol and Drug Programs in the 99/00 amount of \$18,228,544 as  
10 a condition of receiving State funds for substance abuse treatment; and, be it


11 FURTHER RESOLVED, That said agreement shall include an indemnification and the


