

1 [Appointing Mayor to ABAG's Finance Authority for Nonprofit Corporations]

2 APPOINTING MAYOR WILLIE L. BROWN, JR. AS THE REPRESENTATIVE OF THE CITY
3 AND COUNTY OF SAN FRANCISCO TO THE GOVERNING BOARD OF ABAG'S FINANCE
4 AUTHORITY FOR NONPROFIT CORPORATIONS.

5 WHEREAS, By Resolution No. 532-96 of the Board of Supervisors, Supervisor Barbara
6 Kaufman was appointed as the City's Representative to the Governing Board of the Finance
7 Authority ("Authority") for Nonprofit Corporations of the Association of Bay Area Governments
8 ("ABAG"), and she has served in this capacity since her appointment; and,

9 WHEREAS, Supervisor Kaufman wishes to be replaced as the City's Representative to
10 ABAG's Finance Authority for Nonprofit Corporations; and,

11 WHEREAS, Any elected official of the City and County of San Francisco may serve as
12 the City's Representative on the Governing Board of ABAG's Finance Authority for Nonprofit
13 Corporations, as designated by the Board of Supervisors of the City and County of San
14 Francisco; now, therefore, be it

15 RESOLVED, That Mayor Willie L. Brown, Jr. is hereby appointed as the City's
16 Representative to the Governing Board of ABAG's Finance Authority for Nonprofit
17 Corporations for all purposes of representing the City's interests and exercising the authority
18 of the City with respect to the Authority, and for voting on behalf of the City on all matters
19 delegated to the Governing Board of the Authority. The Representative is hereby authorized
20 to appoint up to two qualified persons to serve as alternate Representatives to act in his place
21 in all matters authorized herein. This appointment shall become effective immediately upon
22 approval of this resolution, as provided in the Charter of the City and County of San
23 Francisco.




