2 URGING THE PORT OF SAN FRANCISCO TO ACCEPT A MONUMENT HONORING THE
3 BAY AREA VETERANS OF THE ABRAHAM LINCOLN BRIGADE IN HARRY BRIDGES

6 WHEREAS, 2700 American volunteers fought in the Abraham Lincoln Brigade in Spain
7 between 1936 and 1938; and,

8 WHEREAS, These volunteers fought for the democratically elected government of
9 Spain against Spanish fascists and the forces of Nazi Germany and Fascist Italy; and,

10 WHEREAS, 800 of these volunteers gave their lives in what is now regarded as the
11 first battle of World War Two; and,

12 WHEREAS, Exclusionary laws (Jim Crow laws), or custom, relegated African
13 Americans to segregated military units; and,

14 WHEREAS, The Abraham Lincoln Brigade was the first non-Jim Crow, non-segregated
15 military organization in the country; and,

16 WHEREAS, Many of the volunteers of the Abraham Lincoln Brigade were
17 longshoreman, dock workers and seamen from the San Francisco waterfront, who, along with
18 the other volunteers from many walks of life, were harassed instead of honored by their own
19 government when they returned from Spain; and,

20 WHEREAS, Official recognition of the contributions of the Abraham Lincoln Brigade to
21 the struggle for democracy and justice is long overdue; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
23 urges the Port of San Francisco to accept a monument to be placed in Harry Bridges Plaza
24 honoring the Bay Area Veterans of the Abraham Lincoln Brigade.
