2 AUTHORIZING THE MAYOR OF THE CITY AND COUNTY OF SAN FRANCISCO TO
3 RETROACTIVELY ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$200,000.00
4 FROM THE U.S. DEPARTMENT OF JUSTICE - OFFICE OF JUSTICE PROGRAMS TO
5 ADMINISTER THE "STATE AND LOCAL DOMESTIC PREPAREDNESS EQUIPMENT
6 SUPPORT PROGRAM."

8 WHEREAS, the Mayor of the City and county of San Francisco
9 desires to undertake a project entitled, "State and Local Domestic
10 Preparedness Equipment Support Program", to be funded through the
11 U.S. Department of Justice - Office of Justice Programs; and,

12 WHEREAS, the City and County of San Francisco will utilize
13 Domestic Preparedness Equipment Support funds for the procurement of
14 specialized emergency response equipment; and,

15 WHEREAS, this equipment will enhance the capability of the City
16 and County of San Francisco's Police Department, Fire Department and
17 Department of Public Health to respond to a terrorist incident; and,

18 WHEREAS, the Department proposes to maximize use of available
19 grant funds on program expenditures by not including indirect costs
20 in the grant budget; now, therefore, be it

21 RESOLVED, That the Board of Supervisors hereby waives inclusion
22 of indirect costs in the grant budget; and be it

23 FURTHER RESOLVED, That the Mayor of the City and County of San
24 Francisco is authorized to execute on behalf of the Board of
25 Supervisors of the City and County of San Francisco the Grant Award

1 Agreement, adhering to the requirements and conditions specified by
2 the Department of Justice, including any extensions, amendments
3 thereof; and be it

4 FURTHER RESOLVED, That it is agreed any liability arising out of
5 the performance of this Grant Award Agreement, including civil court
6 actions for damages, shall be the responsibility of the grantee and
7 the authorizing agency. The United States Government and the
8 Department of Justice disclaim responsibility for any such liability;
9 and be it

10 FURTHER RESOLVED, That the Board of Supervisors authorizes the
11 Mayor of the City and County of San Francisco to apply for
12 retroactively, accept and expend a grant in the amount of Two hundred
13 Thousand dollars (\$200,000.00) from the U.S. Department of Justice -
14 Office of Justice Programs to administer the "State and Local
15 Domestic Preparedness Equipment Support Program."




