2 **AUTHORIZING THE MUNICIPAL TRANSPORTATION AGENCY TO ACCEPT AND**
3 **EXPEND \$3,203,169 OF REGIONAL ASSISTANCE FOR ONE MUNICIPAL RAILWAY**
4 **TRANSIT PROJECT.**

5 **WHEREAS**, The Metropolitan Transportation Commission is authorized to make bridge toll
6 net revenue monies available pursuant to the Assembly Bill 664; and

7 **WHEREAS**, The Municipal Transportation Agency, City and County of San Francisco, is
8 an eligible claimant for assistance pursuant to the Assembly Bill 664; and

9 **WHEREAS**, This year the Bridge Toll Net Revenue program provides for \$3,203,169 of
10 capital assistance to the San Francisco Municipal Railway for the purpose of replacing aged motor
11 coaches; and

12 **WHEREAS**, The Municipal Transportation Agency proposes to maximize use of available
13 grant funds on program expenditures by not including indirect costs in the grant budget; now,
14 therefore, be it

15 **RESOLVED**, That the Municipal Transportation Agency is authorized to accept and expend
16 \$3,203,169 of capital assistance to the San Francisco Municipal Railway for the purpose of
17 replacing aged motor coaches; and be it

18 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of
19 indirect costs in the grant budget; and be it

20 **FURTHER RESOLVED**, That the Municipal Transportation Agency is authorized to
21 furnish whatever additional information might be requested by the funding agencies in connection
22 with this request.




