2 URGING CORPIS CORPORATION TO DESIST FROM THE UNAUTHORIZED SALES AND
3 DISTRIBUTION OF FOUR MURALS COMMEMORATING THE HISTORY AND STRUGGLE
4 OF THE UNITED FARM WORKERS LOCATED IN SAN FRANCISCO'S MISSION DISTRICT
5 ENTITLED, "¡SI SE PUEDE!", "EL LENGUAJE MUDO DEL ALMA", "THE FIVE SACRED
6 COLORS OF CORN", AND "MAESTRAPEACE".

7 WHEREAS, Dolores Huerta, along with the late Cesar Chavez founded of the United
8 Farm Workers to advocate for the rights of California farmer workers; and

9 WHEREAS, In order to commemorate the history of the UFW, Cesar Chavez, and the
10 struggles of farm workers, muralist Susan Cervantes and many other artist under the direction
11 of Dolores Huerta created four murals placed throughout the Mission District; and

12 WHEREAS, Corbis Corporation is a Bellevue, Washington based company founded
13 and owned by Microsoft CEO Bill Gates; and

14 WHEREAS, Corbis Corporation allows users to purchase, email and print digital images
15 of fine arts and photography; and

16 WHEREAS, Corbis Corporation has incorporated the four murals containing UFW logo
17 and symbols and selling the electronic images to its customers; and

18 WHEREAS, Dolores Huerta, Susan Cervantes and the UFW have filed a lawsuit
19 against Corbis Corporation for trademark and infringement of sales and distribution of four
20 murals located in San Francisco's Mission District: "¡Si Se Puede!", "El Lenguaje Mudo del
21 Alma", "The Five Sacred Colors of Corn", and "MaestraPeace"; now therefore be it




