6 WHEREAS, Supervisor Mabel Teng was first elected in 1994 and re-elected in 1998 to serve
7 the people of the City and County of San Francisco; and,

8 WHEREAS, Supervisor Teng has served this community with a generosity of spirit, a
9 sense of urgency for issues impacting the quality of life, and a commitment to bettering the
10 lives of San Franciscans; and,

11 WHEREAS, Supervisor Teng's remarkable service includes distinguished membership
12 on the San Francisco Transportation Authority, the Golden Gate Bridge, Highway and
13 Transportation District Board, and several Board of Supervisors' Standing Committees,
14 including the Housing and Social Policy Committee and the Finance Committee over which
15 she presided as Chair; and,

16 WHEREAS, Throughout her terms in office, Supervisor Teng committed her boundless
17 energy to improving education and child care, advocating for civil rights, fighting graffiti, and
18 promoting pedestrian safety, among many other causes; and,

19 WHEREAS, Supervisor Teng authored numerous pieces of significant legislation,
20 including those establishing a new Children and Families First Department and creating the
21 City's first ever Pedestrian Safety Summit; now, therefore, be it,

22 RESOLVED, That the members of the Board of Supervisors, on behalf of the officers,
23 employees, and citizens of this City, do hereby take public recognition of the distinguished
24 contributions which Supervisor Mabel Teng has made to the welfare of this community, and

1 do express their appreciation for her exceptionable work, their thanks for her judicious
2 presence, and their best wishes in her future endeavors; and be it

3 FURTHER RESOLVED, That a framed copy of this resolution be tendered to
4 Supervisor Mabel Teng as a token of the great affection and respect in which she is held by




