WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That the Department of Public Health, Community Mental Health Services, is hereby authorized to accept retroactively and expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it


FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it

3 Health if the grant recurs or is renewed; and, be it


4 FURTHER RESOLVED, That the Controller should be urged to designate the


