

1 **[SALE OF FLOWER MARKET PERMIT]**

2 APPROVING THE ASSIGNMENT OR SALE OF THE FLOWER MARKET PERMIT IDENTIFIED AS "THE  
3 UPPER MARKET STREET FLOWER MARKET LOCATED ON THE NORTH SIDEWALK OF SIXTEENTH  
4 STREET WITHIN 100 FEET SOUTH OF THE SOUTHERLY LINE OF MARKET STREET" TO A QUALIFIED  
5 PERMIT APPLICANT PURSUANT TO ARTICLE 5 SECTION 161(h) OF THE PUBLIC WORKS CODE.

7 WHEREAS, Christos Keratzedes, the permittee who operated the flower market located on the  
8 corner of 16<sup>th</sup> and Market Streets, requests permission to sell said permit as stipulated in Article 5, Section  
9 161(l) of the Public Works Code; and,

10 WHEREAS, Mr. Karatzedes, upon approval by the Board of Supervisors, shall be given thirty  
11 (30) working days to sell or assign said Street Flower Market; and,

12 WHEREAS, The buyer or assignee shall comply with all rules and regulations governing Street  
13 Flower Markets (Article 5 – Public Works Code); including but not limited to having been a resident of  
14 City and County of San Francisco for a period of one year prior to application; and,


15 WHEREAS, The buyer or assignee of said Street Flower Market shall maintain minimum  
16 operating hours of Monday through Friday, between 10:00 AM to 5:00 PM; and


17 WHEREAS, The buyer or assignee of said Street Flower Market shall operate and maintain said Street  
18 Flower Market in accordance with Article 5 and to a condition acceptable to DPW, including but limited to  
19 graffiti removal and the removal of flower cuttings.




