3 **Resolution appointing Rebecca Dandois, Cheryl Magid, Francisco Casique, and Akua**  
4 **Jackson, terms ending August 20, 2003, and Michelle Horneff, term ending August 20,**  
5 **2001 to the Lead Poisoning Prevention Citizens Advisory Committee; waiving**  
6 **residency requirement.**

8       RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
9 does hereby appoint the hereinafter designated persons to serve as members of the Lead  
10 Poisoning Prevention Citizens Advisory Committee, pursuant to the provisions of the San  
11 Francisco Health Code, Section 1607, for the term specified:

12           Rebecca, Dandois (residency requirement waived), Seat 1, succeeding Jans Wan,  
13 must have expertise in childcare, unexpired portion of 4-year term ending August 20, 2003;

14           Cheryl Magid, Seat 2, succeeding Virginia Aguilar, must have expertise in childcare,  
15 unexpired portion of 4-year term ending August 20, 2003;

16           Francisco Casique (residency requirement waived), Seat 3, succeeding Sandra  
17 Carrillo, must represent a tenant organization, unexpired portion of 4-year term ending August  
18 20, 2003:

19           Michelle Horneff, Seat 14, succeeding Michael Miller, must have expertise in real  
20 estate, new 4-year term ending August 20, 2001;

21           Akua Jackson (residency requirement waived), Seat 20, succeeding Basheem Allah,  
22 must have expertise in neighborhood concerns, unexpired portion of 4-year term ending  
23 August 20, 2003; and, be it

24           FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 1            1. The membership of the Lead Poisoning Prevention Citizens Advisory Committee  
2            has a goal to be representative of the diversity of the City and County of San  
3            Francisco.
- 4            2. Applicants Rebecca Dandois, Francisco Casique, and Akua Jackson, new  
5            appointees, who are not residents of San Francisco, are persons with experience  
6            that uniquely qualifies him/her to serve on the Lead Poisoning Prevention Citizens  
7            Advisory Committee.
- 8            3. The Lead Poisoning Prevention Citizens Advisory Committee has attempted to fill  
9            the positions, for which Rebecca Dandois, Francisco Casique, and Akua Jackson  
10           were nominated, with individuals who are City residents and who have the specific  
11           experience, skills, and qualifications, but have been unable to do so at this time.  
12           The Rules Committee has certified Rebecca Dandois, Francisco Casique, and Akua  
13           Jackson as qualified to serve on the Lead Poisoning Prevention Citizens Advisory  
14           Committee.
- 15           4. After exercising due diligence, the Board of Supervisors concludes that there is no  
16           other possible representative, who are residents of San Francisco and who have  
17           the specific experience, skills, or qualifications possessed by these applicants, and  
18           who are willing to serve on the Lead Poisoning Prevention Citizens Advisory  
19           Committee at this time; and, be it

20            FURTHER RESOLVED, That the Board of Supervisors waives the residency  
21            requirement for Rebecca Dandois, Francisco Casique, and Akua Jackson, as allowed in  
22            cases where no qualified City resident, willing to serve, can be found, pursuant to Section  
23            4.101 of the City Charter that requires person(s) appointed to boards, commissions, and  
24            advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of  
25            the City and County of San Francisco.




