8 WHEREAS, The Department of Public Health has applied for and been
9 awarded a grant from State Office of AIDS in the amount of \$50,000 for a survey of
10 low income young men to measure the prevalence of HIV, STDs, hepatitis and
11 related risk behaviors; and,

13 WHEREAS, As a condition of receiving the grant funds, The State Office of
14 AIDS requires the City to enter into an agreement (the "Agreement"), a copy of which
15 is on file with the Clerk of the Board of Supervisors in File No. 010439, which is
16 hereby declared to be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The grant terms prohibit including indirect costs in the grant
19 budget; now, therefore, be it


20 RESOLVED, That the Board of Supervisors hereby waives inclusion of
21 indirect costs in the grant budget; and be it

22 FURTHER RESOLVED, That the Department of Public Health is hereby
23 authorized to accept retroactively and expend the grant funds pursuant to San

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City.




