8 WHEREAS, On May 8th, 2000, the Department of Public Works entered into an
9 Easement Agreement with the Sloat Garden Center, Inc., Dave Straus, George W. Szakall II,
10 Theodore I. Warshauer and Linda K. Warshauer (collective and individually, "Grantor") and
11 the City and County of San Francisco ("CCSF"); and

12 WHEREAS, The Department of Public Works agreed to the following: 1) Transfer of
13 Sign; 2) Grant of Easement; and 3) Maintenance in which work reasonably required to keep
14 the Sign in a safe condition during the Term; and

15 WHEREAS, The Department of Public Works assumed the responsibility for the
16 maintenance of the sign at its present location and for relocation for the sign; and

17 WHEREAS, The Department of Public Works assumed the responsibility for the cost of
18 maintaining the sign in safe condition; and

19 WHEREAS, This agreement is on file with the Clerk of the Board of Supervisors in File
20 No. 00-0324 , which is hereby declared to be a part of this resolution as if set forth fully
21 herein; and now, therefore, be it

22 RESOLVED, That the Board of Supervisors strongly urges the Department of Public
23 Works to immediately follow through with its commitments to the Doggie Diner Head; and, be


