7 WHEREAS, The California State Legislature is currently negotiating the 2001-2002 FY
8 budget; and,

9 WHEREAS, State Senator Jackie Spieir ~~has requested the addition of \$3.56 million in~~
10 the state budget in order to fund the Stormwater Diversion Program at Lake Merced; and,

11 WHEREAS, Stormwater used to naturally flow into Lake Merced; however,
12 development around the Lake has resulted in the stormwater being diverted out into the
13 Pacific Ocean; and,

14 WHEREAS, The Stormwater Diversion Program that will be funded by Senator Spieir's
15 ~~and Assemblyman Shelly's~~
\$3.56 million proposal will redirect the stormwater back into Lake Merced; and,

16 WHEREAS, The addition of this stormwater into the Lake will, in addition to other
17 corrective measures, dramatically improve the water level at Lake Merced, as well as the
18 overall environment at Lake Merced; now, therefore, be it

19 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
20 urges the State Legislature to include \$3.56 million in the State's FY 2001-2002 budget, as
21 requested by Senator Spieir, ~~and Assemblyman Shelley~~
22 for the Stormwater Diversion Program at Lake Merced.




