9 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
10 does hereby appoint the hereinafter designated persons to serve as members of the Asthma
11 Task Force, pursuant to the provisions of San Francisco Administrative Code, Chapter 19A,
12 Article II, for the term specified:

13 Ann Togia, new appointment, seat 1, must be a representative of community-based
14 organization that provides advocacy related to asthma issues in San Francisco, for a new two-
15 year term ending June 30, 2003;

16 Rose Toney, new appointment, seat 2, must be a representative of community-based
17 organization that provides advocacy related to asthma issues in San Francisco, for a new two-
18 year term ending June 30, 2003;

19 Deanna Rossi, new appointment, seat 3, must be a representative of childcare
20 coordinating/advocacy organizations, for a new two-year term ending June 30, 2003;

21 Marie Hoemke (residency requirement waived), new appointment, seat 4, must be an
22 individual who is either persons with asthma, the parent of a child with asthma, or an asthma
23 patient advocate, for a new two-year term ending June 30, 2003;

2 persons with asthma, the parent of a child with asthma, or an asthma patient advocate, for a
3 new two-year term ending June 30, 2003;

5 persons with asthma, the parent of a child with asthma, or an asthma patient advocate, for a
6 new two-year term ending June 30, 2003;

7 Ann Melamed, new appointment, seat 7, must be a representative of an environmental
8 health/justice organization, for a new two-year term ending June 30, 2003;

9 Mary Higgins, new appointment, seat 8, must be a representative of an environmental
10 health/justice organization, for a new two-year term ending June 30, 2003;

11 Carolyn Noble (residency requirement waived), new appointment, seat 9, must be a
12 representative of a hospital association or health care provider institution, for a new two-year
13 term ending June 30, 2003;

14 Peg Strub, new appointment, seat 10, must be a representative of a hospital
15 association or health care provider institution, for a new two-year term ending June 30, 2003;

16 Carla Furtado, new appointment, seat 11, must be a representative of MediCal
17 Managed Care Insurers, for a new two-year term ending June 30, 2003;

18 Ben Loewy, new appointment, seat 13, must be a representative of lung
19 health/asthma-specific organizations, for a new two-year term ending June 30, 2003;

20 Beth Saiki, new appointment, seat 14, must be a representative of lung health/asthma-
21 specific organizations, for a new two-year term ending June 30, 2003;

22 Barbara Conner Andersen, new appointment, seat 15, must be an individual who
23 represents health care professions working with asthmatics, for a new two-year term ending
24 June 30, 2003;

1 Julie McKown (residency requirement waived), new appointment, seat 16, must be an
2 individual who represents health care professions working with asthmatics, for a new two-year
3 term ending June 30, 2003;

4 Lisa Kroon, new appointment; seat 17, must be an individual who represents health
5 care professions working with asthmatics, for a new two-year term ending June 30, 2003;

6 Diedra Epps-Miller, new appointment, seat 18, must be an individual who is an
7 academic researcher or educator concerned with asthma issues, for a new two-year term
8 ending June 30, 2003;

9 John Balmes (residency requirement waived), new appointment, seat 19, must be an
10 individual who is an academic researcher or educator concerned with asthma issues, for a
11 new two-year term ending June 30, 2003;

12 Micheal Walter Green (residency requirement waived), new appointment, seat 22, must
13 be an individual who represents tenant interests (non-voting member), for a new two-year
14 term ending June 30, 2003; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the Asthma Task Force has a goal to be representative of the
17 diversity of the City and County of San Francisco.
- 18 2. Applicants, Marie Hoemke, Carolyn Noble, Julie McKown, John Balmes, and
19 Micheal Walter Green, new appointees, who are not resident of San Francisco, are
20 persons with experience that uniquely qualifies him/her to serve on the Asthma
21 Task Force.
- 22 3. The Asthma Task Force has attempted to fill the position, for which Marie Hoemke,
23 Carolyn Noble, Julie McKown, John Balmes, and Micheal Walter Green were
24 nominated, with individuals who are City residents and who have the specific
25 experience, skills, and qualifications, but has been unable to do so at this time. The

1 Rules Committee has certified that Marie Hoemke, Carolyn Noble, Julie McKown,
2 John Balmes, and Micheal Walter Green are qualified to serve on the Asthma Task
3 Force.

- 4 4. After exercising due diligence, the Board of Supervisors concludes that there are no
5 other possible representative, who are residents of San Francisco and who have
6 the specific experience, skills, or qualifications possessed by these applicants, and
7 who are willing to serve on the Asthma Task Force at this time; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for
9 Marie Hoemke, Carolyn Noble, Julie McKown, John Balmes, and Micheal Walter Green as
10 allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to
11 Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions,
12 and advisory bodies established by legislative act of the Board of Supervisors to be
13 resident(s) of the City and County of San Francisco.


