6 **implementation of a community prosecution project entitled "Operation Second**  
7 **Chance", and waiving indirect costs due to funding constraints.**

9 WHEREAS, The City and County of San Francisco desires to continue to engage the  
10 community in its ongoing work on public safety and crime prevention issues; and,

11 WHEREAS, The Office of the District Attorney has been awarded a grant in the amount  
12 of \$179,250 by the United States Department of Justice, Office of Justice Programs ("OJP"),  
13 administered by the United States Bureau of Justice Assistance ("BJA"), for the  
14 implementation of a community-based project designated "Operation Second Chance"; and,

15 WHEREAS, Under this project, the District Attorney's Office will work with other  
16 agencies of the criminal justice system and community-based organizations to hold youthful,  
17 street-level narcotics offenders responsible for their actions, while at the same time working to  
18 provide vocational services, employment, mentoring, support services and substance abuse  
19 treatment for participating defendants; now, therefore, be it

20 RESOLVED, That the District Attorney of the City and County of San Francisco is  
21 retroactively authorized on behalf of the City and County of San Francisco to accept and  
22 expend funds from BJA for Operation Second Chance; and be it

23 FURTHER RESOLVED, That indirect costs are waived due to funding constraints; and


