3 Resolution authorizing the San Francisco Department of Public Health,

7 WHEREAS, The San Francisco Department of Public Health (SFDPH) has  
8 applied for and been awarded a one year grant from Join Together in the amount of  
9 \$60,000 for a social marketing campaign to increase community support for substance  
10 abuse treatment in San Francisco; and,

11 WHEREAS, As a condition of receiving the grant funds, Join Together requires  
12 the City to enter into an agreement (the "Agreement"), a copy of which is on file with the  
13 Clerk of the Board of Supervisors in File No. 011096, which is hereby declared to be  
14 a part of this resolution as if set forth fully herein; and,

15 WHEREAS, The grant terms prohibit including indirect costs in the grant budget;  
16 now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect  
18 costs in the grant budget; and, be it

19 FURTHER RESOLVED, That the SFDPH is hereby authorized to accept and  
20 expend the grant funds in accordance with the requirements set forth in the Agreement,  
21 pursuant to San Francisco Administrative Code section 10.170-1; and, be it






